The 2018 ISO Annual Meeting was held at the Graduate Hotel in Iowa City on September 16-17, 2018. Sunday's session featured lectures on a variety of interesting topics from the University of Iowa faculty. Topics included early treatment, airway considerations, as well as other clinical pearls. Monday's sessions featured Dr. **Peter Ngan** who discussed *Early Timely Orthodontic Treatment: Is it Worth the Burden?* 

The 2019 ISO Annual Meeting will be held Sunday and Monday, October 13-14, 2019. The Sunday session will occur at the University of Iowa College of Dentistry featuring Dr. **Tom Southard** and the residents and faculty of the Iowa Orthodontic Department. Monday's program will take place at the Graduate Hotel in Iowa City and will feature Dr. **Shane Langley** from South Alabama Orthodontics speaking on a variety of clinical topics.

In January 2019, the lowa Dental Board began the process to enact rules that would define standards of practice for teledentistry. The AAO's Mr. **Trey Lawrence** attended the January Iowa Dental Board meeting to express the AAO's concerns with the draft and offered suggestions for improvement so that the proposed amendments would best protect the health and safety of Iowa's patients. The rules were then open for written public comment through May 15. The AAO, along with many of its Iowa members, sent the Board comments with ways in which the draft rules could be revised to ensure that teledentistry in Iowa would be carried out in the best and safest way for patients and practitioners. A public hearing for the proposed rules has been scheduled for Wednesday, July 24 at 2:00 pm in Des Moines, and all Iowa members are encouraged to attend. The AAO will continue to monitor and participate in the rulemaking process.

## Osborne receives 2019 Shepard Distinguished Service Award

Dr. James W. Osborne, formerly of Lake Winnebago, Missouri and currently of



DeSoto, Kansas, was unanimously selected by the Midwestern Society of Orthodontists Board of Directors as the recipient of the 2019 Earl E. Shepard Distinguished Service Award.

Dr. Osborne received his dental and orthodontic degrees from the University of Missouri-Kansas City School of Dentistry in 1972 and 1976, respectively. He served in the United States Army Dental Corp from 1972-1974 before beginning his orthodontic residency. Dr. Osborne practiced

full-time in Raytown, Lee's Summit and Pleasant Hill, Missouri from 1976-2012.

While in practice, he served in an adjunct clinical instructor at the UMKC School of Dentistry, Orthodontic Department. After five months of retirement, he joined the faculty of UMKC School of Dentistry, Orthodontic Department as a clinical faculty member and assisted in the teaching of the residents. After the retirement of Dr. Don Thompson, he became the Clinical Director of the Advanced Education in Orthodontics at UMKC. He is now serving as the Interim Chair and Clinical Director of the program.

Dr. Osborne served as president of the Missouri Society of Orthodontists in 1982-1983; as president of the Midwestern Society of Orthodontists in 1998-1999; as editor of the *Midwestern Society of Orthodontists Newsletter* from 1993-1996; and as a delegate to the AAO House of Delegates several times. Most importantly, Jim served as the MSO representative to the AAO Council on Communications, leading to the development of the consumer awareness program. In his local professional community, he served as president of the Greater Kansas City Dental Society; the Eastern Jackson Dental Society; and the Kansas City Orthodontic Support & Research Foundation (the UMKC Orthodontic Alumni Association). He was the long-term treasurer and meeting coordinator for that organizations' annual meeting.

Jim was also involved in many community boards and committees, including the Lee's Summit Parks and Recreation Board; the Raytown, Lee's Summit and Pleasant Hill Chambers of Commerce; the Lee's Summit School District Advisory Committee; the Lee's Summit Optimist Club; the Raytown Rotary Club; and many committees within the Lake Winnebago Homeowners Association, including serving as president for several years.

We are very thankful to our alumni and friends for their continued support to the UIC Department of Orthodontics. Our alumni and friends supported endowments that are enabling us to conduct high quality research. The Dr. Allan G. Brodie Craniofacial Endowment funds clinical and translational research to bring the most advanced 21st century technology, leadership and innovative science to the Brodie Institute and accelerate discovery that brings novel treatments and interventions to patients in Chicago and around the world. Our model of translational research is based on bioinformatics and to use massive repositories of clinical genetic data in order to identify patterns relevant to the delivery of clinical care. We are in the process of creating a named research center and establishing a state of the art 3D imaging lab to further our imprint in areas of big data analytics, clinical and translational orthodontics, and craniofacial growth and development. The 3D imaging lab will primarily serve departmental faculty and residents working on 3D research on topics such as sleep apnea/airway management; growth and development; surgical outcomes assessment; and CAD/CAM orthodontic appliances. The lab will enable us to implement digital technology in our curriculum, develop a comprehensive digital orthodontics course for our residents and also continuing education workshops covering diagnostics and treatment planning, multiple imaging acquisition technology, real-time simulation, virtual appliance construction monitoring and adjustment as well as overcoming obstacles in pre-programmed appliances, and assessment and evaluation of treatment outcomes.

With support of our alumni and friends, we are in the process of creating several resident scholarships. During this academic year, we created an Endowed Scholarship for our residents. This scholarship provides \$20,000 annually in tuition support.

Our alumni reception was held during the AAO Annual Session in May in Los Angeles. The event was very well attended and it was a great get-together of the UIC Orthodontics family. We are in the process of creating "Alumni-Resident mentorship program/rotation". We will be pairing our current residents with alumni to explore practice opportunities and learn more about practice management.

#### **MAYO CLINIC**


The end of the 2019 Academic year brings us to another successful transition in Orthodontic education here at Mayo Clinic.

The course will cover the histological response of initial healing process of surrounding alveolar bone in mini-screws, the basic biomechanical aspects of the use of mini-screws as an orthodontic

Dr. Deguchi is an Associate Professor and Graduate Program Director in the Division of Orthodontics at the Ohio State University College of Dentistry. He completed his dental training at the Aichi-Gakuin University and received PhD at the Okayama University. He also had his orthodontic training at the Indiana University. He has been focusing his clinical interests in the field of temporary anchorage device (TADs), lingual orthodontics and interdisciplinary cases. He has been also engaged in the research field such as histomorphometric studies related to tooth movement and pain related studies. Dr. Deguchi is a Diplomate of American Board of Orthodontics and a member of the Midwest Angle Society. Dr. Deguchi has lectured as invited speaker at the European Orthodontic Society, American Association of Orthodontics and in other international meetings all around the world.

## **AMERICAN BOARD OF ORTHODONTICS (ABO)**

#### **Clinical Examination Update:**

- The ABO conducted Clinical Examinations in February and September in 2018 and February 2019. A total of 449 orthodontists were certified/recertified at these examinations. A complete listing by examination and constituency can be found on the ABO website.
- The first Scenario-based Oral Clinical Examination was successfully administered in February 2019 with a 68% pass rate. Traditional Clinical Examinations were also offered by petition only in February 2019. June 2019 will mark the final time case-based examinations will occur.

Response to the new examination has been overwhelmingly positive. Overall, examinees shared that they were pleased at how well organized and professionally handled the examination details were administered. Feedback received included:

- "Overall, I appreciate the ABO's commitment to strive for excellence and improvement and would recommend any orthodontist take the new exam. I truly feel I have become a better orthodontist because of it."
- "You walk out of the exam feeling humbled and grateful for the time you guys spent investing in us and our profession."
- o "Overall, the experience was humbling, inspiring and educational!"

The next Scenario-based Oral Clinical Examination is scheduled for November 2019. The examination is full with a wait-list.

Registration for the 2020 exams opened on May 22, 2019. An additional examination has been added due to anticipated demand. Examinations will now be offered February, July and November 2020.

Study materials and online resources are available to assist in preparing for the Scenario-based Oral Clinical Examination including a Study Guide and Sample Cases (with questions and answers). Orthodontic programs interested in hosting case-based mock board exams are welcome to contact ABO examiners to request a school visit. ABO advocates are available to visit orthodontic programs if requested. Prep Courses to assist in preparing for the examination will be offered at various times throughout the year in collaboration with the College (CDABO).

Once board certification is achieved, Certification Renewal is required every 10 years to remain on an Active status and may be taken no earlier than two years prior to the expiration date on your certificate. There are two options to re-certify and travel to St. Louis is NOT required:

- Complete two online Board Case Exams as provided by the Board AND submit CE credits from online AJO-DO exams; or
- Submit one case treated by the examinee (see website for criteria) and submit CE credits from online AJO-DO examinations.

## **Written Examination Update:**

 The 2019 American Board of Orthodontics Written Examination was administered one day only on April 10, 2019 to 422 examinees at Pearson Vue Testing Centers throughout the United States and Canada. The reliability of the examination was 90% with a 96% pass rate. The next Written Examination will be offered on April 7, 2020. Eligible individuals may register for this exam beginning this fall. As a reminder, once the Written Examination is successfully completed, it never expires.

  specific dashboard notifications, make annual fee payments and view payment history,
  upload and track CE credits, print complimentary verification letter.

## **COUNCIL ON COMMUNICATIONS (COC)**

The Consumer Awareness Program (CAP) continued to crush our goals for FY2019. The program amassed over 1.2 billion impressions. This means that AAO ads were seen by users over 1.4 billion times. The COC set a goal of 5 million views for our newly redesigned website and had 7.3 million page views. During the past year, we reached over 100 million unique consumers and our ads have appeared in over 9.7 million search results for a variety of orthodontic topics.

As listed on the AAO members page: Digital marketing platforms currently being utilized by the Consumer Awareness Program include, but are not limited to

- Paid search (Google, Yahoo! and Bing)
- Website banner ads
- Social media outlets (Facebook, Instagram, Twitter, Snapchat)
- Online video
- Email marketing

The AAO's digital paid advertising is behaviorally targeted to individuals who are researching orthodontic treatment topics online. In addition, Search Engine Optimization (SEO) work is underway and is generating additional organic (unpaid) search traffic to the AAO consumer website, aaoinfo.org. We continue to reach consumers through a wide variety of digital platforms. This year, our ads appeared on Facebook/Instagram, Snapchat, Google search and display, YouTube, AdRoll and Buzzfeed.

Our website has become a trusted and key resource for online searches. Our consumer website was redesigned and relaunched during the fall of 2018. This redesign has greatly improved customer experience. This is measured via decreased bounce rates and an increase in time spent on the site and an increase in page views. We are constantly improving the site and adding new content to our blogs. These improvements have also led to an increase in organic (unpaid) visits to our site. Our Parents Guide to Orthodontics is a huge draw to our site, with consumers spending several minutes on the pages. In addition to our website, you may have seen some of our informational alerts. We recently put out a consumer alert on the dangers of using at home aligners. Our goal is to become "THE" source for orthodontic information online.

Why are visits to the website important? 90-95 percent of today's consumers conduct research online before making any purchase decision – including an investment in something like orthodontic treatment. The increase of traffic to our website tells us the CAP is successful at making the AAO more visible and easily found online; and more patients are being educated about the importance of seeing an orthodontist. With the robust amount of patient education materials on the consumer website, we want consumers to find it and learn the importance of seeing an orthodontist.

Did you know that 75% of all Americans perform online searches for healthcare related topics? Adult orthodontic patients often research long and hard before they embark on their treatment journey. They search not only for hard data but many search for reviews. Recent Google research indicates that some adults take years before they initiate treatment.

## CAP stats in Canada

At the start of this year, the AAO initiated an intensive social media campaign in Canada, targeting parents and other adults and using the "That Feeling When..." video series. From January 1 - May 31, the CAP in Canada reached more than 7.3 million consumers and brought more than 342,000 to the AAO website. These results compare with Canadian results of 3.5 million and 21,000, respectively, for all of 2018.

Another goal of the Council on Communications is to better inform our members. We have not only redesigned our member website but have started to provide updates to our members via private orthodontic Facebook groups. Group administrators have graciously allowed us to share "breaking news" with our members, which allows us to reach many members quickly when needed. ## **COUNCIL ON ORTHODONTIC EDUCATION (COE)**

CODA announced in May a change in the process for Submission of Self-Study Documents. In lieu of sending both a comprehensive paper and comprehensive electronic copy of a program's Self-Study to site visit teams and the Commission, CODA is asking Programs to submit their self-studies in the form of a: 1) a comprehensive electronic copy of the Self-Study (narrative along with exhibits, appendices, support documents, etc.); and 2) a paper copy of the narrative portion only of the Self-Study. This will alleviate the volume of paper work and printing costs from both the programs and the commission.

Earlier this year circulation of Proposed Revised Standards was initiated by CODA. All comments were due June 1, 2019 for consideration at the summer 2019 Commission meeting for Accreditation Standards for Advanced Dental Education Programs in Orthodontics and Dentofacial Orthopedics. These revisions include proposed changes in curriculum and program duration, Standard 4-3.4.

Also at its winter 2019 meeting, the Commission on Dental Accreditation directed that additional proposed revisions of Orthodontic Accreditation Standards be distributed to the communities of interest for review and comment, with all comments due December 1, 2019 for consideration at the winter 2020 Commission meeting. These revisions are related to Standards 2 and 3 and designed to improve contemporary teaching and learning. The first hearings on Proposed Orthodontic Accreditation Standards were held by CODA at the March 2019 American Dental Education Association (ADEA) Annual Meeting in Chicago, Illinois.

The 2019 Jeryl D. English Educational Leadership conference, held in conjunction with the AAO Annual Session in Los Angeles this past May, was a success and well attended. President **Kelton Stewart's** leadership team did an outstanding job in putting together a fantastic program for over 100 educators.

ABO directors were available to answer questions on Certification Renewal and the Scenario-based Oral Clinical Examination at the May AAO Annual Session in Los Angeles. They reported that the response to the new examination was positive. The next Scenario-based Oral Clinical Examination will be held in November 2019 and is currently full. Registration opened up on May 22, 2019, for the three examinations offered in 2020. The ABO Written Examination was administered April 10, 2019. Participants should have received the results.

The SOE website has a number of resources for educators. A recent podcast by Dr. **Padma Mukherjee**, SOE president-elect, discusses *Women as Educators in Orthodontics* with Dr. **Kate Vig**.

The Midwestern Society of Orthodontists' fall meeting is October 25-26 in Branson, Missouri. The Council on Orthodontic Education will host the University Chairs on

## **COUNCIL ON ORTHODONTIC HEALTH CARE (COHC)**

The Council on Orthodontic Health Care met on June 22, 2019 at AAO Headquarters. The meeting was chaired by Dr. **Kim Batterson**. An update from the board liaison, Dr. **Norm Nagle**, gave information on the AAO strategic plan, decision making and governance. The Council then discussed access to care, and the AAO's initiative into access to care. Discussion centered on expanding the reach of the program and how that could be accomplished. The Council forwarded its recommendation to the board for consideration.

A report on the ADA's Code Maintenance Committee (CMC) in March centered on a few minor changes to the CDT coding manual related to orthodontic codes. The AAO also had proposed a preamble for the orthodontic section of the CDT manual to further define orthodontic care, however that change was voted down by the CMC. The Council discussed ways to further that idea at next year's CMC meeting. The Council also discussed the ADA's request that AAO look at all of the orthodontic codes and review them as they have not been modified for a number of years.

A brief report from the American Association of Dental Consultants (AADC) meeting in May focused on trends that are being seen in dentistry and insurance industry. While many of the issues were not specific to orthodontics, payer issues and concerns, practice modalities, and other topics were discussed over the 3-day meeting. Outside of the scheduled lectures, there was discussion of how some insurance companies are considering direct payments to direct to consumer entities and the concerns of many insurance companies about that occurring.

COHC reviewed the revised medically necessary orthodontic guidelines that were passed by the HOD in May and will not make any recommended revisions at this time. We also heard reports from staff on COGA and COC activities.

In new business, the Ensuring Lasting Smiles Act (ELSA) that is proposed legislation in Washington for insurance companies covering all care related to craniofacial anomalies was discussed and applauded by the Council. There were also discussions of teledentistry and DSO's but no actions were taken by the Council related to those topics.

The Council also will be electing the new chair for the next year. Results of that will be announced during the January conference of COHC.
