## Policy Manual: Board Committees

Each component director shall be assigned to one of the standing committees by Nominating Committee chair for election at the Annual Member Business Meeting. Meetings shall be at the call of the chairman or any three of the members.

## Budget and Finance Committee:

The secretary-treasurer will serve as chair of the committee and the incoming secretary-treasurer will serve as the vice-chair. When possible, this position should be used to "groom" the next MSO secretary-treasurer. In addition to the chair, committee members shall consist of the president-elect, secretary-treasurer and three component directors (one being the incoming secretary-treasurer). The committee should annually review the preliminary estimates of income, expenditures and reserves; examine the annual budget and prepare specific recommendations to the Board and membership; and recommend the financial and investment program of the Society per the financial policy.

## Nominating Committee:

Chaired by the president-elect, the committee shall also include the president and three component directors (not eligible for nomination). The committee should present their recommendations at the Ad Interim Board Meeting on nomination for the offices of presidentelect and secretary-treasurer annually and trustee as needed. Per Bylaws, nominations should be approved by the Board and submitted in writing to membership prior to the MSO Annual Session for election at the business meeting. The committee presents the list of nominees for MSO's delegates and alternate delegates to the AAO House for summer Board approval (selected after AAO Annual Session) so the committee's report can be presented to the active membership prior to the MSO Annual Session Business Meeting. The Nominating Committee chair is responsible for securing a commitment based on Executive Committee approval for the following year's secretary-treasurer nominee so this leader can be placed as vice chair on the Budget and Finance Committee the year before serving as secretary/treasurer.

## Annual Sessions Committee:

Chaired by the president-elect, the committee shall also consist of the secretary-treasurer and three component directors. The committee should recommend changes in the Annual Session Planning Guidelines, work with other constituencies and components to encourage joint meetings and investigate and propose future annual session sites/rotation patterns. The future incoming president responsible for their annual session's year shall work with the executive director to determine appropriate site options to recommend to the board based upon the board's rotation and joint meeting preferences.

## Shepard Award Committee - Earl E. Shepard Distinguished Service Award:

The committee shall consist of the last three most immediate past presidents with the longestserving past president serving as chair (3/11). The duty of this committee is to select an annual awardee. This award will not be made when no suitable nominations are available. Nomination should be presented for Board approval at the Ad Interim Board Meeting (approx. 18 months prior to presentation). The chair shall notify the named recipient after the Board meeting, coordinate the biographical write-up for the Annual Session program booklet, and deliver or assign the onsite presentation of the award. Refer to under Awards for Shepard Award implementation policy.
