The 2017 ISO Annual Meeting was held at Hotel Vetro in Iowa City on October 8-9, 2017. Sunday's session featured lectures on a variety of interesting topics from the University of Iowa faculty. Monday's sessions featured Dr. **Eustaquio Araujo**. He discussed a variety of topics including the management of impactions, nonsurgical Class III treatment, 1 vs 2 phase treatment and treatment of hyperdivergent cases.

For more than a year, the lowa Dental Board ("Board") has been analyzing its specialty advertising laws. At its January 2018 meeting and as a complete surprise to all those in attendance, the Board's conversation went from revising lowa's specialty advertising laws to completely removing them. With that in mind, in early April 2018 the Board was only focused on one action item – rescinding/removing Iowa's specialty advertising laws. That, of course, would have allowed any lowa dentist (general or specialist) to use the word "specialist" or other specialty terms in their advertisements. After several calls and emails with the Iowa Dental Board's Executive Director, the AAO's Sean Murphy was able to convince the Board to add a second option to the agenda – that would narrowly revise the dental specialty advertising regulation to only account for the American Board of Dental Specialty groups (implantology, anesthesia, oral medicine, orofacial pain). The Board agreed, and at the Board's April 2018 meeting, several orthodontists and Mr. Murphy made public comments to the Board, convincing them that revising Iowa's specialty advertising regulation was far better than removing it. The Board agreed unanimously and voted to put forward the proposed revision, which will now go through the typical rulemaking process (public comment period, etc.). The Iowa members in attendance were definitely delighted with the outcome and we are all very pleased with the AAO's efforts on this issue.

The advertisement rules were removed from the Missouri Dental Practice Act on April 19, 2018. This was determined to be detrimental to the public in Missouri. **Sean Murphy**, attorney for the AAO, spoke on behalf of the Midwestern Society of Orthodontists and Missouri orthodontists. Mr. Murphy and Missouri Dental Association and the Missouri Dental Board drafted a legislative amendment that strengthens Missouri's advertising laws and, as a result, protects the public. This language was added on short notice to amend the language of HB 1719, which passed in the final hours of Missouri's legislative session. The advertising language that was added is underlined on pages 98-100 in https://house.mo.gov/billtracking/bills181/hlrbillspdf/4489H.05S.pdf

Klarsch receives 2018 Shepard Distinguished Service Award

The Midwestern Society of Orthodontists' Board of Directors unanimously selected Dr. James G. Klarsch of Des Peres, Missouri, as the recipient of the 2018 Earl E. Shepard Distinguished Service Award. This award recognizes a member of the MSO who exemplifies the ideals of the orthodontic profession, community and family. He received the award during the business meeting of the MSO in Bloomington, Minnesota in September.



Dr. Klarsch, a St. Louis native, received his Bachelor's degree, with Honors, from the University of Missouri at Columbia and was chosen to be a member of Mystical 7, the most prestigious Honor Society at MU. In 1984, he earned his Doctorate of Dental Surgery (DDS) "With Distinction" from the University of Missouri Kansas City School of Dentistry. There, he was inducted into Omicron Kappa Upsilon, the National Dental Honor Society.

Post-graduate work began with a General Practice Residency program at Southern Illinois University at Edwardsville School of Dental Medicine/St. Mary's Hospital. Dr. Klarsch then completed his post-graduate education in orthodontics

at St. Louis University Center for Advanced Dental Education/Department of Orthodontics. Graduating at the top of his class, he received a Master of Science (MS) degree and has been practicing orthodontics since 1988.

Today, Dr. Klarsch is dedicated to his field with a thriving practice that is limited to the Specialty of Orthodontics for children, adolescents and adults. AAOF LEADERSHIP UPDATE

In March, the AAOF was pleased to welcome **Jackie Bode** as our new Executive Director while wishing **Robert Hazel** a wonderful retirement after devoting 26 years into making the Foundation what it is today. Jackie brings significant development experience to the AAOF through her prior appointments. Most recently, as executive director and senior development manager for the Christian Hospital Foundation in St. Louis, she created an annual giving program that, over four years, saw a 539% increase in the fund balance. She founded a planned giving program and secured the Foundation's first planned gift of \$100,000 in 2017. AMERICAN ASSOCIATION OF ORTHODONTISTS POLITICAL ACTION COMMITTEE (AAOPAC)

The AAOPAC and the AAO Council on Governmental Affairs had an informal meeting during the AAO Annual Session in Washington, D.C. on May 8.

The AAO hosted its 2018 Professional Advocacy Conference in conjunction with the Annual Session. We planned it that way in an effort to take advantage of the fact that we had so many members already near Capitol Hill – allowing us to involve more AAO members in advocacy efforts, at less cost to the AAO. The results, as you can see from the attached survey responses, demonstrate that the members who participated thought it was a great value to both them and the AAO.

We were able to take the AAO's message to a record number of legislative offices while also effectively involving AAO members in the effort. Our hope and goal is to build on that effort and encourage AAO members to remain engaged at both the national level as well as the state level, where much of the recent advocacy efforts have been targeted.

The AAOPAC and the AAO Council on Governmental Affairs are scheduled to meet again in Washington, D.C., September 24-25, 2018.

Recent legislative activities affecting AAO members and our patients.

First, on July 24, the U.S. House of Representatives passed the Protect Medical Innovation Act (H.R. 184), an AAO-endorsed bill that would permanently repeal the medical device tax. See https://www.aaoinfo.org/news/2018/07/medical-device-tax-repeal-passes-house. As you may know, if the medical device tax is not repealed, it will most certainly affect each of our practices because we would be taxed for orthodontic appliances. Thus, we are working hard to see this legislation have success in the Senate as well.

Then, on July 25, the U.S. House of Representatives passed the Increasing Access to Lower Premium Plans and Expanding Health Savings Accounts Act of 2018 (H.R. 6311). See https://www.aaoinfo.org/news/2018/07/house-representatives-passes-key-element-raise-act. Included in the House's passage of H.R. 6311 is the AAO's own RAISE Act, which was originally introduced by Congressman **Steve Stivers** (R-OH), who relied heavily on AAO members' FSA experiences in sponsoring that legislation. If H.R. 6311 becomes law, an employee's hard-earned FSA contribution would stay theirs from year to year, for an amount up to three times the annual limit before needing to be spent down, thus changing the current "use it or lose it rule." If the Bill passes, imagine how many patients could use saved FSA contributions to pay for orthodontic care.

AMERICAN BOARD OF ORTHODONTICS (ABO)

ABO Yearly Update:

• <u>Clinical Exam Update</u>: In January 2018, the ABO announced a change to the board certification process to a Scenario-based Oral Clinical Examination. This decision was based on extensive research, specialty board reviews and collaboration with industry leaders which identified the need to improve our testing methodology to better assess clinical competency and critical thinking skills. The new examination format will be composed of four domains for assessment. Benefits of the exam include improved testing methodology, tests critical thinking skills and clinical competency, removes unnecessary barriers and helps level the playing field.

The change was communicated via emails, an AAO podcast, and *AJODO* article. In addition, the ABO hosted Open House/Info Sessions during the 2018 AAO Annual Session in Washington D.C. which were very well attended. ABO directors were on-hand to answer questions on the examination and provided sample cases and a study guide for attendees' review. In addition a workshop for educators and advocates was held to provide additional details on the examination format.

Traditional Clinical Examination with case submission requirements will be offered by petition only in September 2018 and February 2019. The Scenario-based Oral Examination will be offered beginning with the February 2019 examination.

The ABO encourages examinees to continue to work through patient cases, and utilize the tools created by the ABO to assess care outcomes, including the Discrepancy Index (DI), Cast Radiograph Evaluation (CRE), Case Management Form (CMF) and Cephalometric Superimpositions.

The ABO conducted Clinical Examinations in both February and September 2017 as well as February 2018. A total of 335 examinees were certified or recertified at these exams. A complete listing of newly certified or recertified orthodontists by constituency can be found on the ABO website. The following MSO candidates received initial certification at the February 2018 exam: Drs. Jennifer Caplin, Jessica Fuller and Nicole Kim.

Upcoming examination dates and fees are also listed on the website.

• Written Examination Update

• The 2018 American Board of Orthodontics Written Examination was administered April 10-13, 2018, to 414 examinees at Pearson Vue Testing Centers throughout the United States and Canada. The reliability of the examination was 92%, with a 96% pass rate. The next Written Examination will be offered April 9-12, 2019. Eligible individuals may register for this exam beginning September 4, 2018.

COUNCIL ON COMMUNICATIONS (COC)

Consumer Awareness Program (CAP)

The CAP is now in its 13th year. Its purpose is to raise awareness among consumers about the benefits of orthodontic treatment provided by AAO orthodontists. This contributes to meeting the AAO's mission as stated in our Strategic Plan: to advance AAO members' success through education, advocacy and research that drive excellence in patient care.

CAP outreach includes paid messaging (advertising) and public relations (stories in the news media). Paid messages are delivered digitally using search engines (Google, Yahoo!, Bing), websites and social media ads. We also work with other online avenues to distribute more modern content; for example, we worked with Buzzfeed to develop three videos, which were released in the 2017-18 fiscal year. Those videos can be viewed here: buzzfeed.com/aaortho

The advantages of digital marketing are many. Vast amounts of data about consumers enable us to tailor and deliver messages to a variety of audience segments, based on gender, age, household income, whether there are children in the household, and an array of other factors.

Whether paid or unpaid, all messages drive consumers to aaoinfo.org where they can learn more about orthodontic treatment provided by AAO members, and then locate nearby AAO members through the "Find an Orthodontist" search.

Messaging is doing a phenomenal job of driving record numbers of traffic to the website. Here is a recap of FY 2017-18 results:

- 800+ million online ad impressions (an impression in digital advertising is the number of times an ad appears on a screen to a user)
- 120+ million unique consumers reached
- AAO ads appeared through search engines (Google, Yahoo!, Bing) more than 7 million times
- More than 50% of these ads appeared in searches for people who were Googling information on a direct-to-consumer orthodontic products
- "Likes" on consumer Facebook page grew by 2,500%
- 5.5+ million visits to the consumer website
- 75,000+ active searchers on the "Find an Orthodontist" feature on the consumer website

Getting visitors to the website is half the battle. The other half is giving them useful information. Our goal is that aaoinfo.org becomes "the" resource for consumers who have questions about orthodontic care. With that result in mind, the COC has enhanced the site's content. Blogs have been added, and they can be credited with significantly increasing the amount of time visitors spend on our site. Most recently we added *The*

Parent's Guide to Orthodontics – a comprehensive resource for parents that answers their questions before, during and after orthodontic treatment. A guide for adult orthodontics will be added to the site, and there are plans to increase the frequency of blog posts.

The "Find an Orthodontist" service has been enhanced, making consumers' ability to contact AAO orthodontists nearly effortless. Based on search parameters, those who use "Find an Orthodontist" receive a list of AAO members. They can search through the list and gather phone numbers or click on members' website links; they can also click a button to request an appointment, fill in a form, and the form is delivered to the member via their business e-mail address. If visitors are accessing "Find an Orthodontist" through a smart phone, they can click an icon and place a call to the orthodontist's office. About 90% of website visitors come to the site via a mobile device.

How to Make the CAP Work for You

Here are a few simple steps you can take as an AAO member to make the CAP work for you.

- Make sure the AAO has your practice website address. The URL appears with your name and other contact information when you are "found" on "Find an Orthodontist", and when it is clicked, it links to your website.
- Make sure the AAO has a business e-mail address on file. If an interested consumer wants to request an appointment through "Find an Orthodontist", their completed form is delivered only to your business e-mail address.
- Follow the AAO's consumer social media outlets (Facebook, Twitter, Instagram, YouTube).
- Share AAO-created content for consumers on your social media outlets and/or website.
- Make sure the AAO member logo appears "above the fold" on your practice website. (If you need files, login to aaoinfo.org/members and go to https://www.aaoinfo.org/practice-management/market-your-practice/member-logos.)

COUNCIL ON ORTHODONTIC EDUCATION (COE)

Dr. **Ken Dillehay**, BOT Liaison to the Council on Orthodontic Education (COE), reported that the Board voted to reinstate the Faculty Fellowship Award Program for a 3-year period beginning in 2019. Of the 20 former Fellows who previously received fellowship awards, all but one has remained in academics. The remaining 19 orthodontic faculty members have generated 153 years of teaching and current indicators suggest they will stay in orthodontic program settings for the foreseeable future. Other AAO-funded Fellowships have similar successful outcomes to help address the faculty shortage, but more positions exist than are filled. This trend is anticipated to worsen.

This spring the American Board of Orthodontics announced changes in the clinical examination process. Scenario-based examinations will improve the Board's ability to assess clinical proficiency and critical thinking skills. Scenario-based testing is utilized by several other medical and dental specialty boards. The new examination design will require an orthodontist be proficient in four key domain areas: data gathering and diagnosis, treatment objectives and planning, treatment implementation and management, and critical analysis and outcomes assessment. The ABO has included a one-year transition period prior to fully implementing the new design for the February 2019 clinical examination. The Board will continue to provide guidance to educators including those graduate programs located in the MSO region.

The 2018 Rolf G. Behrents Educational Leadership Conference Society of Educators (SOE) was recently held in conjunction with the AAO 2018 Annual Session. This was a well-planned and excellent conference with over a 100 of the nation's orthodontic educators in attendance. **Steven Siegel**, University of Maryland and AAO Trustee and **Kelton Stewart**, SOE President-Elect, Indiana University, discussed important revisions to the CODA accreditation standards that are being proposed. These included establishing a minimum FTE per resident for clinic coverage as well as updating mandatory experience in contemporary appliances (aligners) and procedures (TADs/lasers). This discussion is in the very early stages and likely a topic at the Fall MSO Educator's Conference to be held at the Radisson Blu Mall of America, September 22, 2018 in conjunction with the MSO meeting.

Lastly, CODA recently communicated to its communities of interest that it will refer to all advanced dental education disciplines as advanced education programs. This includes orthodontics and dentofacial orthopedics. As a result, it has removed *specialty* terminology from the standards and website. Speaking on behalf of the AAO, President **Brent Larson** noted, "This is really a clarification to avoid a misunderstanding of CODA's role. CODA is responsible for accrediting dental education programs of all types and does not, and has not, been responsible for recognizing specialties." It should be noted that the AAO has strongly advocated the position that a licensed dentist seeking specialty recognition must have successfully completed an advanced education program of at least two full-time academic years, and that the program be accredited by an agency that is recognized by the United States Department of Education.

COUNCIL ON ORTHODONTIC HEALTH CARE (COHC)

The COHC has continued working on issues related to access to orthodontic healthcare, insurance coding and third-party payer issues. Our Council meeting was on June 10, at AAO headquarters in St. Louis. This year we have a new board liason, Dr. **Ken Dillehay** from Wichita, Kansas.

Dr. Dillehay gave the board a report on the updated AAO strategic map and governance structure. The new strategic map easily lays out AAO's goals and objectives in an easy to read single page format. This is important for councils to be able to refer to this document to ensure that their actions are consistent with the strategic plan. This document will be an important tool for the decision making process. Dr. Dillehay also went through the COHC self-assessment that we filled out earlier in the year. Council members feel we are meeting the objectives of our charge and have the appropriate resources at AAO to accomplish our tasks.

Next, **Ann Sebaugh** reviewed data on the cases treated by DOS during the first half of this year. There is a desire to see significantly more cases treated pro-bono by our membership to improve access to care for underserved populations. Having a large number of our colleagues volunteering to provide this type of care in their practices would help to educate the public to the charitable contributions of the orthodontic community. This would certainly be usable by COC to cast our profession in an even better light. At this time, COHC is exploring ways to increase access to care for underserved populations.

Moving on to CDT coding topics, it is relevant to note that I am currently serving on the ADA Council on Dental Benefit Plans and the Coding subcommittee. This will be important over the next year as COHC reviews all orthodontic codes to determine if there a benefit to revising some, or all, of the codes. It has been over two decades since the orthodontic codes have been modified and it is good practice to review them at this time to make sure they are relevant. COHC is also currently working to get "Box 40" on the ADA claim form removed. Box 40 is to be checked when an adjunctive service is provided for orthodontic purposes, such as extractions or canine exposures. This allows insurance companies to use the orthodontic benefit to cover the non-orthodontic procedure.

We reviewed the AAO Medically Necessary Orthodontic auto-qualifying conditions to see if the current language is acceptable. Utilizing data from the state of Nevada that uses these for their Medicaid orthodontic approval and a retrospective study on Medicaid cases in Washington, the Council felt that a review of these with some editorial changes to the list would be appropriate. As we move forward, private insurance could utilize these auto-qualifying conditions for coverage and we should regularly review them and relevant data to gauge their effectiveness.

The next COHC meeting is a conference call on January 12, 2019, and the summer meeting will be at AAO Headquarters on June 22, 2019.

COUNCIL ON MEMBERSHIP, ETHICS AND JUDICIAL CONCERNS (COMEJC)

The AAO House of Delegates has adopted a revision to the AAO Code of Ethics.

COMEJC Principles of Ethics, Code of Professional Conduct and Advisory Opinions of the American Association of Orthodontists

RESOLVED, that the *Principles of Ethics, Code of Professional Conduct and Advisory Opinions of the American Association of Orthodontists* be amended to include the following:

PRINCIPLE 3: MEMBERS HAVE THE DUTY TO TREAT PEOPLE FAIRLY (Justice)

CODE OF PROFESSIONAL CONDUCT:

- **3.A.** Members shall be dedicated to generating public confidence in the orthodontic specialty by improving the quality and availability of orthodontic and dental care to the public.
- **3.B.** Members shall recognize and abide by the laws that apply to the practice of dentistry and orthodontics in their jurisdiction.
- **3.C.** Members shall provide a workplace environment devoid of harassment or inappropriate behavior and a workplace that upholds respectful and cooperative relationships for all employees and patients.

ADVISORY OPINIONS:

- **3.A. (i)** Members may exercise discretion in selecting a patient into their practice, provided that they shall not refuse to accept a patient because of the patient's race, creed, color, sex, national origin, disability, HIV seropositive status, or other legally recognized protected class.
- **3.A.** (ii) Members should pursue changes in laws, requirements, rules and/or regulations within their jurisdiction that are contrary to the best interests of patients.
- **3.A.** (iii) It is ethical to accept for treatment or complete treatment for a patient who has an outstanding balance with a previous practitioner.
- **3.A.** (iv) It is ethical to remove appliances from, or to continue treatment for, a patient not of record upon request by that patient; provided, that all reasonable effort should be made to determine the reason for the request from the patient. It is advisable to consult with the patient's practitioner, if possible, prior to such removal or continuation of treatment.
- **3.A.** (v) It is ethical to withdraw from treating a patient of record, provided that advance written notice to the patient or responsible party is given in accordance with state/provincial laws so as to allow for another provider to be secured.
- **3.A. (vi)** It is ethical for members to provide dental care other than orthodontics unless announcing a practice that "is limited to" orthodontics.
- **3.B. (i)** It is ethical to decline accepting a patient not formerly of record for continuation of routine orthodontic care after being seen for emergency treatment.

- **3.B.** (ii) Members may assign to an auxiliary or other employee only those duties for which they have been appropriately trained and that can be legally performed by such individual in the member's jurisdiction.
- **3.B.** (iii) Members with first-hand knowledge that a colleague is practicing while chemically impaired shall urge such colleagues to seek treatment and have an ethical responsibility to report such evidence to the appropriate state or provincial regulatory body or dental board as required by law.
- **3.B. (iv)** Members should become familiar with signs of abuse and neglect and must report suspected cases to the appropriate authorities in the manner prescribed by state or provincial laws.
- **3.C. (i)** Members shall refrain from inappropriate interpersonal relationships or behavior within the orthodontic workplace and shall promote mutual respect, professional communication and cooperative efforts of all team members to enhance excellence in orthodontic care and assure safe and professional relationships with and between employees and patients

COUNCIL ON NEW AND YOUNGER MEMBERS (CONYM)

With the 2018 Annual Session in Washington, D.C. marking the end of the AAO calendar year, it also marked the completion of CONYM's first year serving as liaisons to other councils. From all accounts, this has been met with much success from both CONYM's standpoint and the other councils. The flow of information and collaboration between councils was enhanced and a better understanding was had by all as to the needs of our association's NYMs and what various councils can do to assist in serving them. CONYM looks forward to continuing this relationship into the future.

As CONYM has now served in the aforementioned liaison positions, the 2018 House of Delegates passed a resolution allowing for CONYM to select one member to partake in, as non-voting liaisons, all quarterly Board of Trustees Meetings. This resolution passed unanimously in the HOD and was a significant step forward for NYMs to ensure that their voices are heard at the highest level of our association.

The 2018 Annual Session in Washington, D.C. was a busy one for CONYM as the Council hosted its first "Lunch with Leaders" which was a rebranding of the AAO "Town Hall" event. Previous attendance had been lackluster due to poor location and timing as it was often up against general session lectures. This event was held in the exhibit hall during non-lecture hours and all attendees were given a boxed lunch. Attendees had the opportunity to sit with their constituencies CONYM representative as well as their respective Trustee. This seemed to meet with great success as we had over 80 individuals attend and an enjoyable time was had by all discussing AAO initiatives, AAO member benefits, and any questions/concerns that attendees had that they wished to voice with the BOT members that were in attendance.

CONYM also organized the annual New Orthodontist and Resident Conference as part of the Annual Session. This year's keynote speaker was **Andrew Tucker** from the McGill & Hill Group. Mr. Tucker spoke on achieving financial independence for the young practitioner who would like to start saving, but is riddled with student and practice debt which often makes this difficult. Following the lecture, informational roundtables were conducted with topics ranging from how to start a practice to legal pitfalls facing new business owners. This event was very well attended with a final tally of over 170 participants.

CONYM will continue to take part in GORP (Graduate Orthodontic Residents Program) with one of our council members hosting a booth to discuss AAO offerings for our future new and younger members as well as giving a presentation during the general session to give additional information on CONYM and how it serves our younger constituents.

The recently implemented Resident Champion Program continues to be a solid communication line between the AAO's BOT and the residency program with a designated resident within each program relaying information to and from the AAO to the program's residents. This information exchange is vital as CONYM and the AAO attempts to capture our new and younger members while still in school and gain early interest in future involvement within the association.

CONYM continues to be involved with oversight on the AAO's mentorship program. After one full year in action, the Council has decided to continue forward with the individual mentorship arm of this program, but eliminate the group mentorship as this coordination and communication proved difficult for both mentors and mentees. Those who have participated in the individual mentorship, however, have had a very positive experience and we look forward to continuing with this.

In the Spring of 2018, CONYM members reached out to all new and younger members that had not renewed their AAO membership in an effort to secure renewals. By reaching out directly to these individuals, our Council members were able to have one-on-one conversations about our Council, the AAO, and all members' services/benefits that are offered. Of all the contacts made, we had a 58% success rate with renewals.

The BOT has formed an "Annual Session Task Force" following a survey from new and younger members, which stated that the length/timing of the Annual Session is a primary deterrent towards more of our newer members attending. This task force will study alternative registration options including a "weekend only" registration block as well as looking at the length of the Annual Session as a whole to determine if it should be shortened to accommodate the busy lives of our association's members. There is a feeling within the association that it is becoming increasingly difficult for our younger members to take off time to attend the entire Annual Session so the AAO is seeking other options to make attendance more feasible for all.

Thank you for the continued opportunity to represent the MSO and I look forward to continuing to serve.

COUNCIL ON ORTHODONTIC PRACTICE (COOP)

The Council has its next face-to-face meeting on November 10, 2018 at AAO Headquarters. Please let me know if you have concerns or issues you would like addressed.

The 2018 Practice Transition Program was held on May 4 at the Washington Convention Center in conjunction with the AAO Annual Session in Washington, D.C. The program featured Mr. Ken Alexander, Mr. Doug Copple, Ms. Shannon Patterson, Dr. Laurance Jerrold and a DSO panel including industry consultant Mr. Roger Hill. Topics addressed were: Understanding Orthodontic Transitions, Compensation Expectations for Junior and Senior Doctors, Coverage Agreements for Death/Disability/Displacement in Emergency. COOP members Drs. T.J. Albert and Mel Collazo emceed the DSO panel segment.

Also at the AAO Annual Session was the 2018 Orthodontic Career Fair, which was held on May 6. This event was part of a full-day track for residents and new and younger members, immediately preceded by the New Orthodontist and Resident Conference and followed by the Orthodontic Residents' Reception.

During 2017-2018, a series of 11 Webinars were delivered for doctors and/or staff. Lectures included clinical and practice management topics. Each program was marketed to the membership through the *eBulletin*, email blasts and social media. Six Webinars were delivered in the Business of Orthodontics series, which included lectures on marketing effectiveness, financial strategies, technology and data strategy.

COOP discussed many different options for updating the techniques list in the AAO member directory, and was able to make recommendations to the Board of Trustees, which approved for the membership directory and techniques list to be revised to include a general comment box so members could include bracket type or brand, mechanics and any information that a member thinks is pertinent in helping another orthodontist determine if another doctor's practice would be a good fit for a patient transfer.

This program will complement the Resident Champions. These individuals will be appointed program alums, or possibly faculty, to promote AAO information including: schedule of the Resident Vitals, Legal Mini-Course and Financial Management. Appointments go through the Program Chair.

COOP also recommended and the Board of Trustees approved for AAO to establish a closed Facebook group for Orthodontic Staff, in order to help disseminate clinical information and techniques.

- 2. Provide education, training and certification opportunities for orthodontic staff.


