The Annual Meeting of the Iowa Society of Orthodontists was held October 2-3, 2016 at Hotel Vetro, Iowa City. The Sunday session featured presentations by the University of Iowa Department of Orthodontics. Tours of the newly renovated clinical facilities were also offered. The morning session on Monday featured Dr. **Mike Chaffee** presenting on the use of TADs. On Monday afternoon Dr. **Andy Hayes** presented on Class II correction using the Powerscope appliance. The next ISO annual meeting will be held at Hotel Vetro in Iowa City on October 8-9, 2017.

Recruitment efforts continue to establish a network of ISO members participating in the *Donated Orthodontic Services* program in Iowa to provide access to care for those families that cannot afford needed orthodontic treatment.

The 2016 Iowa Mission of Mercy was another complete success with over 1,350 patient encounters and over \$865,000 in free oral health care provided to Iowans. Cedar Rapids is the site of the 2017 Mission of Mercy scheduled for September 29-30.

The Iowa Dental Association leadership currently expects to revisit dental patient protection, which addresses the right of patients to assign their insurance benefits to the dentist of their choice. The change in the Iowa Senate to a Republican majority will likely complicate the IDA's plans to move these issues forward. It is also expected that the Iowa hygienists will again initiate an effort to limit the need for hygienists to be supervised by an Iowa licensed dentist. IDA leadership continues to oppose this initiative.

The Minnesota Dental Foundation has launched a program called the *Minnesota's Heroes Orthodontic Program*. The goal is to provide free orthodontic treatment for children and spouses of Gold Star Families (immediate family members of those killed in Iraq/Afghanistan, post 9/11) who are considered "in need" of orthodontic care. As of this fall, two teen-age girls are in active treatment – one in southwestern Minnesota and one in the western suburbs of Minneapolis. The regular meeting of the Missouri Society of Orthodontists was held November 4, 2016 at at the Swissotel in Chicago, during the Midwestern Society's Annual Session.

Discussion centered around the CAP program. Missouri, with Dr. Jim Klarsch's leadership, is one of 10 components who have received a matching grant from the AAO to run a consumer awareness campaign via Facebook designed by Athorn Clark and Partners. The campaign began August 3, 2016 and as of November 2, 2016, 130,235 consumers (women age 25-35) have been reached with 4,304 clicks directly to our Missouri Society's Webpage and to the AAO doctor locator page. This will cost our component \$44,000 over the next two years. Approximately \$15,000/year is funded from special assessment from Missouri members and the remaining dollars out of Missouri Society's treasury.

There was discussion around the possibility of selecting an Executive Director for the Missouri Society of Orthodontists. **Kristi Burmeister** offered a proposal that was discussed by attendees. Decision was made to table discussion until a defined list of needs and expectations could be developed. Responsibilities might include consistent contact with members, website management, filings with state and tax authorities and consistent maintenance of meeting minutes.

The Missouri Society website will be changed to same format as Midwestern Society of Orthodontists with a small decrease in cost to the Missouri Society.

Discussion around a possible second meeting each year in addition to the combined Missouri – Kansas meeting that is held yearly. This discussion was tabled until a later date.

The combined Missouri – Kansas meeting will be held January 27-28, 2017 in Kansas City. Please see all the details at <a href="https://www.moortho.org">www.moortho.org</a>. Barbeque, great orthodontic lectures and the Kansas City Royals general manager are on the agenda.

#### **SOUTH DAKOTA**

The South Dakota Society of Orthodontics (SDSO) held its 2016 annual meeting in conjunction with the MSO Annual Session in Chicago. All South Dakota officers were elected for two-year terms at our 2015 annual meeting, which was held in conjunction with the 2015 MSO meeting in Rochester. SDSO member, Dr. **Rick Fuchs**, was elected as the 2016 president of the AAOF.

Our 2017 SDSO annual meeting will be in conjunction with our SDSO annual CE meeting scheduled for March 17, 2017, in Deadwood, South Dakota. Our speaker is Dr. **Peter Kierl**, from Oklahoma, who is a longtime Suresmile user and will talk about an all-digital orthodontic practice. We encourage all orthodontists in the surrounding states to support the program.

The South Dakota Dental Association along with Delta Dental, assisted all dental providers who accept Medicaid through the state's revalidation process, which is a 5-year cycle in South Dakota.

The recent enforcement of a section of the Affordable Care Act (Section 1557) prohibits entities that receive federal financial assistance from discriminating on the basis of race, color, national origin, age, disability and sex. The rule applies to dental offices that serve Medicaid patients. Compliance requirements include "providing meaningful access to individuals with limited English proficiency" as well as providing qualified interpreters and translators.

The rule requires covered dental practices to post two notices: (1) a Notice of Nondiscrimination and (2) Taglines. These notices must be posted by October 16, 2016. The taglines must be written in the top 15 non-English languages in your state. Taglines are short statements translated into the appropriate languages, indicating the availability of language assistance services free of charge.

As a member value, the ADA has developed a sample tagline and is providing it in the top 15 languages for states and U.S. territories to all members. The SDDA web site (<a href="www.sddental.org">www.sddental.org</a>) also has a sample of the notice and the tagline translated into the 15 languages required in South Dakota. Delta's language line can be used by dental offices, when translation services are requested by Medicaid patients.

WSO President **Michael Maslowski** was contacted by WKTI radio station in Milwaukee for a 30-minute spot that was aired on Sunday, October 23 for National Orthodontic Health Month.

The WSO Board of Directors approved the allocation of funds for a CAP program. In addition, the BOD approved an upgrade to the WSO website that will make it easier for the public to locate orthodontists in their area.

President Maslowski presented a Consumer Awareness Program to the membership that will begin in October. The goal of the program is to educate the public on the difference between a general dentist and an orthodontist when it comes to providing orthodontic treatment. Materials used will be created and provided by the AAO and \$10,000 has been allocated for this program, in order to obtain the AAO's \$10,000 match.

AAOPAC, which is governed by the AAOPAC Board, goes through a detailed and extensive process of choosing which Congressional candidates receive AAOPAC funding. New research will be conducted for the purposes of developing consumer buyer personas, mapping the patient journey when deciding to have orthodontic treatment, and identifying best practices in marketing at the practice level.

### **COUNCIL ON GOVERNMENTAL AFFAIRS (COGA)**

The AAO Council on Governmental Affairs met at the Westin Washington, D.C. City Center June 13-15, 2016 in conjunction with the AAOPAC meeting. As during our last meeting in March, the primary focus of our Hill visits was to gain Senate support for the RAISE ACT, which came out of COGA as a legislative priority for the AAO membership, our patients and our office staff. RAISE was introduced on the House floor February 27, 2015. Representatives Steve Stivers (R-OH) and Michelle Grisham (D-NM) championed the bill on behalf of the AAO. RAISE stands for Responsible Additions and Increases to Sustain Employee Health Benefits ACT of 2015. If signed into law, the bill would raise the cap on flexible spending accounts (FSA's) to \$5,000; allow for an additional \$500 per each dependent in a family after the first two, thus allowing larger families to elect more in FSA savings; and the bill would eliminate the "use it or lose it" provision, allowing employees to carry over unused sums from year to year without any limit. We are certain this bill could have a very large positive impact on our orthodontic profession, our practices and all associated industries by providing families with more tax-free income to devote to orthodontic care. The AAO sees the bill as one to allow consumers to make more informed choices when they are spending their healthcare dollars. The bill now has over 78 co-sponsors on a bipartisan basis in the House. Senator Kelly **Ayotte** (R-NH) has agreed to introduce the bill in the Senate later this summer.

We were excited to discover that during the time that COGA members were in Washington, the RAISE bill received a formal SCORE for cost. At a SCORE of \$153 million each year for 10 years, we will need to find the "pay for" and this is what our Legislators will research now that we know the cost basis of the bill. Receiving the SCORE was a huge step to determine how feasible the "pay for" will be. Also during our visit and dinner with Rep. Eric Paulsen (R-MN) he discussed a markup of eight bills, which offer relief to small businesses and families by giving them more options to save for future medical needs. These bills were to be brought before the House Committee on Ways and Means and marked up the following day after our dinner with Representative Paulsen. The bills included H.R. 5445 from Representative Paulsen, which would raise the contribution limits to Health Savings Accounts (HSA's). Recognizing the similarity of Rep. Paulsen's provision and the RAISE Act, this was a critical opportunity to enter into the record a statement in support of the RAISE Act. So Tuesday of our meeting, COGA and AAOPAC board members had a chance to meet directly with both Representatives Stivers (R-OH) and Paulsen (R-MN). Rep Paulsen is also the architect of the Congressional effort to eliminate the medical device tax and he worked closely with the AAO on this issue, so after thanking him for his leadership on this important topic, AAO leaders spent time talking with Representative Paulsen about the RAISE Act's potential for legislative action in the future, and the impact it would have on patients across the country.

Tuesday night's positive conversation lead the AAO to work Wednesday with the lead sponsor of the RAISE Act, Representative Stivers to draft a statement which was entered into the record by Representative Paulsen during the markup of the other eight bills. H.R. 5445 on HSA's was reported out of the Ways and Means Committee and awaits further action in the House later this year. While RAISE is not yet that far along in the legislative process, these positive steps during the markup shows momentum continues to build for the FSA improvements contained in the bill. The AAO's advocacy efforts continue to make inroads with key leaders like Representative Paulsen on tax issues and demonstrate once again the value that comes from defending the values of our profession in the public policy arena.

Arnold and Porter's Legislative Team provided a policy review, which included topic "Antitrust and Medical Boards". There have been five antitrust lawsuits against health licensing boards since the Supreme Court's decision on North Carolina Dental Board vs FTC. The Supreme Court ruled against the dental board in this case, which accused the board of illegally suppressing competition by restricting the use of teeth-whitening practices to licensed dental professionals. Teeth-whitening is not defined as the practice of dentistry in North Carolina, thus the Court ruled that the dental board did not have appropriate government oversight. The AAO continues to monitor this issue as many state boards are making changes to their dental practice act accordingly and subsequent to the ruling.

COGA reviewed the topic of "Noncovered Services" where certain limited-scope vision and dental plans require dentist and optometrists to charge specific rates for services and materials that are not covered by the plan. A House bill (H.R. 3323) has been introduced which prohibits non-covered services provisions in dental and vision plans and is endorsed by the American Dental Association and the American Optometric Association. The Council discussed whether this issue should be added to the AAO's legislative agenda and by unanimous vote COGA supported endorsement of H.R. 3323, the "Dental and Optometric Care (DOC) Access Act".

COGA further examined the Affordable Care Act (ACA) delays that were recently passed. Of importance to employers is the delay of the "Cadillac Tax" in which high cost, high deductible employer sponsored health coverage excise tax implementation is halted until 2020. We are continuing to thank our legislators for passing the Tax Extenders Package allowing for a moratorium on the Medical Device Tax through 2017. The Medical Device Tax is very unpopular overall in the legislative community and we therefore empowered our members of Congress to permanently repeal the tax beyond the current 2-year delay. As we know the problem in repeal is the cost. For the two-year repeal a \$3.4 billion dollar price tag ensues and for the period of 2015 to 2025 a repeal of the tax increases the federal deficit by \$24.4 billion. The Senate's Medical Device Access and Innovation Protection Act, spearheaded by Senator **Orrin Hatch**, (R-UT) purpose is to amend the Internal Revenue Code, thus permanently repealing the excise tax on medical device manufacturers and importers. Representative Paulsen, (R) from

Minnesota championed the Medical Device Access and Innovation Protection Act in the House where it passed on June 20, 2015 with 282 co-sponsors.

Though our AAO legislative team feels full repeal of the ACA remains a difficult process, since so many of the initiatives have already been instituted, we continue to work for replacement of the unpopular Affordable Care Act. ACA replacement plan would most likely be headed by House Speaker **Paul Ryan** and would be riding on wins from the Omnibus/Tax Extenders Package and through Republicans continuing to push for full repeal and replacement.

We also reviewed with our legislators and COGA Board the President's 2017 Budget on Higher Education Plan which included provisions to protect and expand the Pell Grant Program; streamline the FAFSA Form; modernize and expand the Perkins Loan Program; change the Pay As You Earn (PAYE) repayment terms for student borrowers to 25 year forgiveness period for students who borrowed as graduate students and made qualifying payments; and plan for total repeal of student loan interest deduction to all new student borrowers.

Thus, as our AAO members had visits on Capitol Hill, we explained to our legislators that the high cost of education in orthodontics and other dental specialties effectively prevents many current graduates from opening practices in rural and underserved communities. We note that COGA voted at our meeting in March to have the AAO endorse three bills that address "College Affordability and Student Debt" since this is the number one priority we hear from AAO New and Younger Members.

- H.R 4223, the Protecting Our Students by Terminating Graduate Rates that Add to Debt (or Post Grad Act) would reinstate the in-school interest subsidy on graduate student loans. The lead sponsor is Rep. Judy Chu (D-CA) and has 17 other cosponsors. The bill is also endorsed by 14 organizations in health care and higher education.
- H.R. 509, the Student Loan Interest Deduction (or SLID) Act, would double the
  maximum allowable deduction to \$5,000 and eliminate the income phase-out on
  deductions. Lead sponsor is Rep. Charles Rangel (D-NY) and has 58 other
  cosponsors. The American Dental Association, American Student Dental
  Association and a number of other organizations have endorsed the bill.
- H.R. 649, the Student Loan Refinancing Act would authorize borrowers under the
  Direct Loan Program to refinance their loans at a rate equal to the interest rate
  of such loans at the time of modification. It would also fix the rate for the life of
  the loan, unless the borrower chooses to modify again. Lead sponsor is Rep.
   Mark Pocan (D-WI) and has 40 other cosponsors. The American Dental
  Association also endorses this bill.

Arnold and Porter recommended that the AAO consider endorsing the year round Pell grant program. COGA will be reviewing this during our next meeting.

The topic of Small Business Taxes led to Council members discussing how personally this relates to each of them as small business owners:

- Members want to be able to sell their business in as simple of a way as possible without having to delineate between goodwill and assets.
- Reimbursement for healthcare now has to go through payroll, and they prefer it not.
- Desire for a healthcare system that allows members to offer employees affordable options.
- A policy that gives incentives to members to offer full-time employment instead of penalizing members for doing so.
- Depreciation schedules adjusted for small businesses.

AAO General Counsel **Kevin Dillard** as COGA staff liaison and **Sean Murphy**, the new AAO Assistant General Counsel have diligently worked on government issues such as assigning new Political Outreach Leaders (POL's) to each state and assisting states with developing a program to use their matching grant in the component \$1 million legal support fund. Mr. Murphy, along with AAO's recently hired Fundraising Firm of Republic Strategies have worked with states to help develop and manage their legislative networking and to assist each state with their Political Outreach Leader Campaign. Republic Strategies has indeed taken the AAO forward with their strategic plan for us and knowledge that the most critical part of raising funds is to change the culture and make solid awareness of what we are doing at the Washington D.C. level. The AAO needs to make members aware of who we are supporting and why and what changes have to be made to emphasize why AAO Political Advocacy is important to each and every individual AAO member.

The Texas Association of Orthodontists was awarded a grant to help them with the issue of dentists in non -ADA recognized specialties that are requesting to be recognized as a specialist. The AAO continues to work with the Texas Board of Dentistry and the orthodontists after the ruling came down deeming it unconstitutional for the State Dental Boards to mandate that a state can only recognize a dental specialty recognized by the ADA. Federal Court ruled that the regulation is an unconstitutional restriction on free speech and prohibited its enforcement against the Plaintiffs. The decision by the Federal Court has been appealed to the 5th Circuit. Mr. Murphy has consulted with a law firm in Austin, who filed an Amicus Brief on behalf of the AAO, as well as the Texas groups for oral surgeons and pediatric dentists. In addition, a Texas lobbyist was hired to help formulate and promote a draft advertising regulation for consideration by the Texas State Board of Dental Examiners, which would benefit and protect consumers.

We are watching these state-by-state concerns closely and now have funds available to assist if necessary. Each state will need to complete an application and explain their use for the funds and then AAO General Counsel and Assistant General Counsel will review the applications with COGA acting as advisor to the process. The AAO BOT approved criteria for component applications for funding including: detailed information of the issue on which the component would like to lobby; proposed costs, along with a recommendation on which lobbying firm/lawyer the organization would like to retain; and a schedule and mechanism for follow-ups to gauge success. COGA encourages each component and constituent organization and each individual AAO member to stay vigilant and abreast of legislative and legal concerns to which the AAO could corroborate and assist with.

The AAO Board of Trustees passed a motion at its February 2016 meeting that COGA be budgeted for one face-to-face meeting each year, and that its second meeting be held virtually. The Council feels that to be effective in its advocacy efforts, it is important to meet face—to-face twice each year. Since COGA and AAOPAC both attend the AAO's Professional Advocacy Conference, it would seem logical to hold COGA's second meeting in conjunction with AAOPAC just prior to the Advocacy Conference. The Council subsequently presented this recommendation to the Board of Trustees who thus agreed that two face-to-face meetings are needed to properly conduct our business in Washington.

The 2017 Professional Advocacy Conference (PAC) Schedule was discussed by COGA and since the President's Elect Conference will not be held in conjunction this year, Council decided by consensus that Professional Advocacy Conference attendees would arrive on Monday, have the Conference run the full day Tuesday followed by a dinner/keynote speaker that evening and then departures would be following Capitol Hill visits on Wednesday. The dates for the 2017 Advocacy Conference are February 27-March 1.

Thank you for allowing me to serve you through COGA. The AAO really does make a tremendous difference in Washington on behalf of our membership, our families and our patients.

# COUNCIL ON ORTHODONTIC HEALTH CARE (COHC)

The COHC has continued working on issues related to access to orthodontic healthcare, insurance coding and third-party payer issues.

The Council has a conference call scheduled for January 28, 2016. This will be my last official meeting as the MSO representative to the COHC as I will complete my six-year term on the COHC. I have truly enjoyed serving in this capacity and I encourage any members interested in serving to contact me or our trustee, **Brent Larson**.

The major issue that the COHC continues to face is the adjudication of insurance claims for "Medically Necessary Orthodontic Care" (MNOC). I have mentioned previously that the payers and the AAO are working on a pilot program to determine if criteria to define MNOC developed by the AAO are feasible and relevant. This pilot has proven to be more complex than first thought so no results are available at this time. The insurers will continue to adjudicate the claims as they see fit, many using criteria developed for state Medicaid programs, while others use unspecified criteria to define MNOC. The COHC is committed to being part of the solution to this difficult issue and will continue to meet with representatives from the insurance industry. Dr. **Steve Robirds**, our COHC coding consultant, attended the NADP CONVERGE Conference in September and he continued the dialogue with insurance representatives who are just as eager as our AAO members to come up a workable solution. Please continue to monitor the AAO website and the *eBulletin* for the most up to date developments. Feel free to contact me with any questions or comments that you might have on this issue.

The ADA Code Maintenance Committee will meet in March 2017. This is your opportunity to submit suggested code changes to the body that has the power to make those changes. Further info on submitting codes can be found on <a href="www.ada.org">www.ada.org</a>. ICD-10 is now the required code set for diagnostic and procedure codes. Currently, most insurers are not requiring diagnostic codes to be included on orthodontic claim forms, but it is only a matter of time before this requirement becomes reality. The software industry has been slow to update practice management software to include fields for diagnostic codes to be added to the insurance claim form and this may be why the insurers have not rejected claims that did not include diagnostic codes. For those members submitting to medical insurance companies, the ICD-10 codes are required and the AAO has an excellent ICD-10 crosswalk available on the AAO website to help prepare these claims.

The AAO Donated Orthodontic Services program continues its expansion across the country, as Texas has recently started a program. The AAO is supportive of all organizations offering free or reduced fee services to the underserved. Please consider helping those that are most in need by donating your services. You will find it to be worthwhile and satisfying. Please contact me if you would like to become an AAODOS Volunteer.

Finally, I would again like to make a plug for the AAO Dental Benefits Advisory Service, which is staffed by **Ann Sebaugh**. The hotline is an excellent resource for members, especially with the changes to the Affordable Care Act and Medically Necessary Orthodontic Care. Ann is ready and willing to help so please use her services.

### COUNCIL ON MEMBERSHIP, ETHICS AND JUDICIAL CONCERNS (COMEJC)

Throughout the past twelve months a COMEJC sub-committee assigned to scrutinize the Association's Principles of Ethics and Code of Professional Conduct has worked diligently to propose an updated document based on recommendations provided last January by Jerry Jacobs, Esq., a leading authority regarding Association Law. The October 2016 passage of Resolution 65 by the ADA's House of Delegates which struck requirements within the ADA Code of Ethics that specialists must limit their practices to that of their declared specialty(ies) has given further reason to reassess the content of our own AAO document.

At the time of this writing, it is unclear if all hurdles can be completed to enable the 2017 AAO HOD to examine potential document changes – but efforts are in motion to attempt to do so. The committee has felt that in addition to the issues mentioned above, a more logically organized and reformatted content of the AAO's Code could improve our membership's ability to utilize the Principles document as a resource in orthodontic practice – an idea that has (unfortunately, in my view) met some resistance.

In addition, discussion for any possible proposals that might modify current bylaws which require "the exclusive practice of orthodontics" by all Active Members of the AAO are necessary. This topic was brought to the 2016 HOD in Orlando, but was deferred for further study without any final resolution. At present, Active (including a sub-category of Life Active), Affiliate, Academic, Student, Service, Retired, International, International Student and Honorary membership categories are recognized.

In light of the ADA's Resolution 65, further scrutiny and reflection on membership requirements will be a topic of discussion during COMEJC's annual Council meeting in January 2017 and undoubtedly again during April's HOD. Other topics that will be discussed during the Council's January meeting include patient abandonment issues, ethics promotion, international membership recruitment and retention as well as any other membership or ethical matters over which the Council might be able to guide in some way. If you have concerns about these or any other matters within COMEJC's purview, please contact me directly by email or phone.

As a result of the HOD's recent changes in term limits, I will be completing my sixth and final year as your MSO representative to COMEJC at the Annual Session. I am grateful for the opportunity not only to have served, but also for the chance to rub elbows with many fine and inspiring colleagues within the AAO. Daring not to attempt a list of those folks here, let me only say that each of us in the MSO should be comforted in the fact that we are exceptionally well represented within both the MSO and AAO, with all energy spent on improving our profession, and especially our practices. Although we might grimace a little when opening our annual membership dues statement, it is my **strongest** belief that the yearly financial commitment we make in our Association

provides a return on investment that far exceeds any other we might consider for ourselves, our businesses and our profession.

# **Council on New and Younger Members (CONYM)**

During the second half of 2016, the Council has met via conference calls to address a number of ongoing efforts aimed at younger member engagement, to analyze the ongoing efforts of the Council to communicate with the younger constituents and to plan for a number of events upcoming in the first half of 2017.

In July 2016, an electronic mentoring program utilizing a platform called *Chronus* was launched as a pilot-study with the intent of incorporating approximately 100 participants (mentors and mentees) who were stratified into two groups: one-on-one mentoring and group mentoring. The initial numbers were quite positive as 94 individuals enrolled with 35 serving as mentors and 59 as mentees. All communication between mentor and mentees occurs online via *Chronus* and plans are being made to connect all who are involved at the Annual Session in San Diego. The AAO was very encouraged with this initial level of interest and intends to fully implement this program in Summer 2017.

The inaugural AAO Town Hall was held at the 2016 Annual Session in Orlando. This event was geared at residents and new and younger members with the intent being to facilitate discussion and answer questions related to pertinent issues germane to the younger member demographic. These issues included the CAP Program, trade/anti-trust issues, the increased presence of DSO's as employment options for new graduates and other orthodontic education issues. Approximately 60 members were in attendance and members of CONYM served as panelists along with Dr. Brent Larson and Mr. Chris Vranas. Plans are currently underway for the 2017 event, which has been expanded to include both a Winter Meeting town hall in February in Fort Lauderdale as well as an Annual Session town hall in April in San Diego. Although the focus will still be towards new and younger members, all membership is invited. Winter town hall panelists will include Dr. Brent Larson, Dr. Norman Nagel and members of CONYM. The format will be Q & A from the audience as well as from submitted questions from those attending the Emerging Leaders Conference, which is taking place in conjunction with the Winter Meeting. This should be a very informative and interactive event.

CONYM has been keeping a close watch over various social media outlets regarding orthodontic commentary involving the AAO and what issues that certain members, particularly those in the early stages of their careers, feel that the association may not be fully addressing. A formal letter was sent to the AAO Board of Trustees documenting this ongoing online dialogue which prompted a fruitful conversation between CONYM and members of the Executive Committee to brainstorm as to how we can best address the needs and concerns of all members moving forward to ensure that the association is viewed as an inclusive group welcoming all practitioners and addressing the needs of its members. Our Council is continuing to work to improve communication with the younger constituents highlighting steps the AAO is taking on their behalf and the positive changes that the organization is making in response to membership feedback.

CONYM has also been sought out for opinions/thoughts/suggestions in regards to several ongoing AAO committees including the AAO Committee to Study Bylaws and the AAO Annual Session Advisory Committee. Our Council is very pleased to serve as an arm to the AAO and appreciative of the opportunity given by the Executive Committee to weigh in on many of the pressing issues within the organization.

In addition to the town hall events at the 2017 Winter and Annual Sessions, CONYM will again host the *New Orthodontist and Resident Conference* in San Diego in April. **Chris Bentson** will be the featured speaker and he will build on the 2016 lecture given by Dr. **Eric Ploumis**. The focus of Mr. Bentson's lecture will be towards "taking the next step" once one's practice modality/setting has been chosen. This event nearly always sells out as over 180 were in attendance in 2016 and we look forward to similar attendance in 2017.

CONYM's annual meeting will be January 20, 2017, in St. Louis with a joint session with COMEJC on January 21. Thank you for the opportunity to serve as our CONYM representative. I am truly grateful.

### COUNCIL ON ORTHODONTIC PRACTICE (COOP)

The Council met at the AAO Central Office in St. Louis on November 12, 2016.

The Resident Vitals School Presentation has been revamped to make it more relevant to current orthodontic residents and better tracking efforts are underway to ensure the information is given to as many orthodontic residents as possible. Other possible changes include the option of introducing an informal meeting held after hours with a recent graduate or adjunct faculty member leading the Resident Vitals dialogue.

The 2017 Practice Transition Seminar is scheduled for Friday, April 21 in conjunction with the AAO Annual Session. It will feature networking and round table lunch discussions. A location in the exhibit hall will be used. Speakers are Mr. Chris Bentson, Orthodontic Market Place Overview: Trends Affecting Owners and New and Younger Members; Mr. Brandon Collier, Not All Group Practices Fail: Structuring the Transition to Address the Big Issues Fairly and Ensure Mutual Success; Dr. Tom Ziegler, Buyers and Sellers: A Guide to Practice Transition; and Mr. Mark Drake and Mr. Merritt Drake, The Evolution of Dentistry: How DSOs are Shaping Orthodontics. The reception again is sponsored by Ziegler Practice Transitions.

The 2017 Orthodontic Career Fair will be held on April 23 in San Diego, California. This event is part of a full-day Annual Session track for residents and new and younger members, immediately preceded by the New Orthodontist and Resident Conference and followed by the Orthodontic Residents' Reception.

COOP reviewed the AAO Informed Consent video and recommended to the AAO BOT that the video be updated to include more information about root resorption and periodontal disease. Once updated by the AAO Services, Inc., the new media format likely used to produce an Informed Consent product will be posted on the AAO website and/or You Tube to protect our members.

In 2016–2017, a series of 12 webinars have been planned for doctors and/or staff. Lectures will be on clinical and practice management topics. A series of six webinars have been planned for *The Business of Orthodontics Webinar Series* which are provided at no charge live or archived for all AAO members.

The Practice Opportunities Service is available to all AAO members, whether looking to sell or buy a practice, or looking for an associate or associateship. This is an extremely valuable member benefit, so if you are looking to make a practice transition, be sure to visit the POS page on the AAO member website or use the AAO app.

COOP is still working with the Council on Membership, Ethics and Judicial Concerns to look into patient abandonment and developing AAO policy related, but not limited to assisting the public and dealing with AAO member repercussions.
