Gjerset becomes AAO president; Isaacson receives Ketcham Award

The 2002 AAO Annual Session in Philadelphia held special significance for the MSO as two of its members were in the spotlight. Dr. **James E. Gjerset**, Grand Forks, North Dakota, was installed as president of the AAO, and Dr. **Robert J. Isaacson**, Edina, Minnesota, received the Albert H. Ketcham Memorial Award from the American Board of Orthodontics.

Familiar to most members of the MSO, Jim is a former trustee and the one individual who has served in so many capacities during his involvement in organized dentistry and his community. He brings a wealth of knowl-

edge and experience to the leadership of our organization.

Jim has served as president of many dental organizations and has been extremely involved with CDABO, North Dakota Dental Foundation, AAOF, ADA and, obviously, the AAO in many different positions

In his community of Grand Forks, Jim also has been quite involved in a variety of diverse organizations.

Jim has received numerous honors for his commitment to dentistry including being inducted as a Fellow of the American College of Dentists, the International College of Dentists and the Pierre Fauchard Academy. He also is a member of Federation Dentaire Internationale and the World Federation of Orthodontists. Moreover, he received the Distinguished Dental Alumnus Award from the University of Minnesota School of Dentistry in 1998 where he received both his dental education and orthodontic training.

It should be a great year for the AAO with Jim, and his wife, LuAnne, leading the AAO into the future.

Dr. Isaacson received his D.D.S., M.S.D. and Ph.D. from the University of Minnesota. He then served as Chair

of the Division of Orthodontics at the University of Minnesota from 1965 to 1977. In 1977 Bob went to the University of California, San Francisco, to chair the Department of Growth and Development. This was the first

This year proved to be very special as the MSO was able to benefit from being heard by two strong voices on the AAO Board of Trustees through the contributions and wisdom of recently installed AAO President **James Gjerset** and MSO Trustee **Lee Graber**. Congratulations, Jim, on your rise to the highest position in our organization, a journey that has been paved with your many years of hard work and dedication to this organization.

The MSO delegation was organized and led in fine fashion by delegation chair Dr. **Mike Inda** and co-chair Dr. **Brent Larson**. Drs. **Steve Marshall** and **John Kanyusik** joined the MSO delegation team as first-year delegate rookies but proved to all to be integral and productive contributors to the cause by introducing MSO resolutions that were readily accepted and passed by the AAO House. Thank you to all members of the delegation for the time that you sacrificed at the meeting to attend to AAO's business.

The biggest overall theme to report to the MSO membership is that due to the House and the AAO's diligent efforts to review existing programs and reduce overall costs, the AAO membership dues to be billed this summer will actually go DOWN from \$816 to \$745 for active members. In addition, next year's budget allows for \$470,666 to be put into the association reserves. The AAO BOT's recommended dues reduction amount is in direct proportion to an earlier dues increase based on the public relations program that will no longer be implemented at the same level.

Registration forms for the 2002 MSO Annual Session in Minneapolis have been mailed, and I encourage you to register early for this weekend opportunity to "catch" the latest information you need to be on the cutting-edge in your practice. We also will be gathering to honor Dr. **James Hugg** as the recipient of the 2002 Earl E. Shepard Distinguished Service Award.

Trustee's Report

I have now completed my first year as Trustee for the MSO. It still is a "learning process." There have been many changes over the past year, not the least of which was **Tom Watters** becoming our Executive Director. In his short time with our organization, he has worked well with the AAO Board of Trustees and seems to be developing a fine working relationship with our 50+ staff members at the central office. Tom, working with our Associate Executive Director **Chris Vranas**, is doing an exemplary job.

One of the big highlights of the meeting in Philadelphia was seeing the MSO's own Dr. **Jim Gjerset** take over the reins as president of the AAO. Jim has worked tirelessly for the organization, particularly in his years as MSO trustee and as an officer of the AAO. He and his wife, LuAnne, have dedicated themselves to many organizations, both civic and professional. It is a benefit of AAO membership to have Jim working for us now as our president. His leadership has been demonstrated in the past and provides a firm footing for the tasks that lie before him this year. When you see Jim during this presidential year, give him a big "thanks" for all of us.

The MSO delegation to the AAO House of Delegates led by Drs. **Mike Inda** and **Brent Larson** is to be congratulated for its work. We were successful in winning approval for a number of initiatives, including the continuation of *Orthodontic Dialogue* as a Web-based publication. For several years now, the AAO has produced this informative publication for our dental colleagues. It will continue to be developed with two issues each year available for downloading and presentation to your fellow dental professionals. This is one more reason you should "click on" to the AAO Web site on a regular basis.

We also were successful at obtaining passage of an initiative suggested by first-time delegate Dr. **Steve Marshall**. By way of background, the American Dental Association will increase the number of "specialty oriented" speakers at its annual sessions. Steve's idea was for the AAO to sponsor an orthodontic speaker at the ADA annual session, with the AAO providing the input. In this way, the AAO helps general dental continuing education and also assures the quality of the speaker to the general dental community. While details have yet to be completed, it is hoped that we will have some input into the 2003 planning by the ADA.

This past year has seen a Task Force on Endorsements review and make suggestions for the relationship between AAO and outside products and services that may be either "endorsed" or "approved." The task force presented the BOT with a well-developed protocol for identification, evaluation and review of products and services that may be of interest to AAO members and might warrant

such status. It is important to initially identify services that may enhance the AAO membership value based on the AAO's vision and values. Products which might be selected must have broad appeal, be cost-effective for our members, be something that is frequently purchased

and is accessible to a reasonable percentage of the membership. Criteria used to evaluate a potential endorsed product or service include evaluations to see if the product meets membership needs, evaluations of the competition for the product or service, financial stability of the provider and an evaluation of the costs and benefits to the organization. All endorsed programs and services are evaluated minimally on a yearly basis to make certain they are performing in a satisfactory manner for the members.

One of the endorsed programs from the AAO is the Business Owner's Policy. This insurance program provides property and business liability coverage with significant flexibility in deductibles and policy limits. AAO members may choose liability coverage up to one million dollars and full replacement value for property coverage. When members purchase the Business Owner's Policy and also have the AAO's professional liability policy, they receive a 10% reduction in the Business Owner's Policy premium. If you are interested in more information on this "endorsed" insurance program, contact **Bob Bartee** at 800/622-0344.

I have been assigned to chair the AAO Endorsed and Approved Services and Products Review Committee for this next year. I would appreciate any feedback – both positive and negative – that you might have. In addition, the committee is always open to suggestions from members in regard to additions or deletions of products and services.

After the AAO Annual Session, the incoming AAO president makes assignments of trustees to various councils and committees. This year I will be the AAO's trustee liaison to the COGA, working with Dr. **Dan Blackwell** who replaces Dr. **Ed Noffel**. Ed has done yeoman service for dentistry by way of his contacts and influence in Washington. As long as I have mentioned Councils, I also want to thank Dr. **Skip Ferguson** for representing the MSO on COSA and wish him luck as he moves to his new position

capacities, is also a past-president of the MSO. He will receive the award during the Saturday business luncheon at the Minneapolis Marriott City Center Hotel at the MSO Annual Session, September 20-21 in Minneapolis.

AAO Council Reports

These reports are submitted by MSO's representative on each of these councils.

Council on Insurance

The last two years have been successful for all insurance plans endorsed by the AAO. Currently, 70% of the U.S. and Canadian membership participates in one or more plans.

LIFE, DISABILITY AND MEDICAL INSURANCE plan participation is up to 64% of eligible U.S. and Canadian members. Younger members are continuing to join the plan as students or at the time of graduation. Benefits up to \$1,000,000 are available to members, and spouses may apply for coverage up to \$500,000 in the Term Life Insurance Program.

The Group Health Plan has had a series of modest rate increases over the last two years. The fastest growing option available is the Medical Savings Account-qualified (MSA) High Deductible Health Plan. MSA's offer significant tax advantages and a retirement saving opportunity. The MSA is available under a traditional (freedom-of-choice) or preferred provider organization option.

The PROFESSIONAL LIABILITY PLAN continued to grow this past year. Over 45% of the eligible U.S. members are now enrolled, and 59% of the new graduates are enrolled in the plan. New business has increased by 7.3%. AAOIC is now the NUMBER-ONE INSURER OF ORTHODONTISTS IN THE WORLD.

Fewer than 2% of those members insured over the last 5-year period filed professional liability claims. The Council, AAO and AAOIC are confident the frequency and severity of incidents will remain low due to the professionalism and training of AAO members. A risk management seminar held at each annual session educates policyholders in understanding professional liability exposures. Policyholders also may purchase a risk management videotape for \$40. This video or seminar attendance qualifies the insured member for a premium discount of 10% for the next two policy years (subject to a maximum 50% discount cap on the Professional Liability Policy).

The AAO BUSINESS OFFICE PACKAGE (BOP) may be purchased independently or in conjunction with the AAOIC Professional Liability Plan. A member insured with the AAOIC Professional Liability Plan also will receive a 10% premium discount on the BOP. Optional worker's compensation coverage also is available.

Council on Membership, Ethics and Judicial Concerns

The COMEJC met January 12, 2002, in St. Louis. The following items were discussed:

- Logo for International Members

The Council reaffirmed its September 18, 2001, action determining that AAO continue to follow the current guidelines for use of the AAO logo as contained in the *Logo Standards Manual*. Input received by Council members from their respective constituent boards was discussed.

- Special Interest Groups

The Council discussed the concept of setting up "special interest groups" that would facilitate focused, issue-specific communication to and among members indicating an interest in specific identified areas of association activities.

- Input for Council Representatives to Ad-Hoc Committee to Study Demographic Trends

The Council discussed at length the recent AAO surveys regarding demographics, member needs and future practice plans of members over 50 years old. Issues identified that should be considered by the Ad-Hoc Committee included:

1. The disparity in the geographic distribution of orthodontists.
2. The probability that there will be fewer orthodontic graduates who will be potential buyers of existing practices.
3. The "busy-ness" issue for general practitioners if caries are eradicated.
4. Re-introduction of preceptorship programs.
5. The need for AAO to develop or modify programs and services to satisfy the changing needs of recent graduates.
6. The effects of any future closings of specialty orthodontic resident programs.

- Disciplinary Proceedings

Ethical complaints that have been referred to the Council are in the process of being investigated, reviewed and acted upon.

The Council's next meeting date has not as yet been established.

Council on Orthodontic Education

The 2002 Orthodontic Educators Conference was held in Philadelphia in conjunction with the AAO Annual Session. The agenda included reports and updates from AAO committees and COE members; an invited presentation on "Competency as an Outcome of Education" by Assistant Dean **G. William Knight**, University of Illinois at Chicago; break-out work groups on developing a standardized competency examination for graduate orthodontics; and a presentation on "Comparison of Treatment Grading Systems" by Dr. **Lysle Johnston**.

After Dr. **Mark Felton**'s remarks as chair of COE, Drs. **Brent Larson** and **Katherine Vig** reviewed the AAO's Technology Action Plan and Distance Learning Plan. Dr. **Orhan Tuncay** discussed some procedural changes proposed for research awards administered through the COSA, particularly the new requirement that manuscripts, not theses, be submitted. Dr. **David Haas** and Mr. **Robert Hazel** explained that decreases in the AAOF investment income reduced the funding available for current research and educational efforts, but that fundraising is satisfactory. ABO President **Don James** discussed Phase III changes that offer different pathways to Board certification for orthodontic educators. The ABO introduced new tracks which give flexibility in case substitutions. It now allows use of some cases supervised by the faculty member in the graduate clinic and permits taking the oral exam separate from the case presentations to extend the time limit.

Dr. **Donald Poulton** discussed accreditation standards and listed issues currently before the Commission on Dental Accreditation. Dr. **Barry Briss** summarized the Tufts recent accreditation experience and led a discussion involving other recently visited programs. After Dr. **George Cisneros** reviewed the survey of the status of GME funding in orthodontic specialty education, Dr. **Bill Knight** gave insights about his successful GME negotiations on behalf of an orthodontic program.

The day's featured topic, "Developing a Standardized Competency Examination," evolved from interest expressed by orthodontic educators about whether an in-service examination similar to those used by pediatric dentistry, oral and maxillofacial surgery and some foreign orthodontic programs could serve as an assessment for program evaluation and accreditation purposes. Break-out groups were asked to provide valid and reliable performance measures to assess specific residency competencies

and proficiencies. Drs. **Bill Knight** and **Carla Evans** directed the presentation of the group reports. The consensus of the educators was that standardized exams were most useful for testing knowledge and comprehension, but that proficiencies involving skills such as analysis, synthesis and evaluation were very difficult to assess.

The Orthodontic Section of the American Dental Education Association will meet in San Antonio in March 2003. The tentative program includes a focus on facilitating approval of human research projects and maintaining patient confidentiality in educational institutions.

Council on Orthodontic Health Care

COHC met in St. Louis in January. Dr. **James Caveney**, AAO Trustee Liaison, gave an extensive report which included an update on the Health Insurance Portability and Accountability Act (HIPAA) regulations. Recent interpretations of HIPAA billing requirements suggest they will apply only to electronic transactions and not to paper claims. The deadline for compliance has been extended until October 2003. For information on applying for an extension, refer to the HIPAA Web site: <http://www.cms.gov/hipaa/hipaa2/default.asp>.

Dr. Caveney also suggested that a new Continuation of Treatment Letter be drafted by the COHC for the benefit of AAO members.

Dr. **John Harrison** reported on the nearly-completed project of an *Orthodontic Insurance Office Manual*. The contents would include information on each state's insurance department, HIPAA information, glossary, types of dental pre-payment plans, orthodontic plan designs and codes, as well as problem resolution. Mr. **Charles Brightwell**, AAO Staff Liaison, presented a draft of the *AAO At-A-Glance Guide to CDT-3 Orthodontic Codes*. The final format will likely be a laminated card for quick referral. Both the manual and the guide could be made available to members on the AAO Web site.

Dr. **Morris Poole** gave a report of the Direct Reimbursement (DR) Committee, including the history of the founding of the Dental Benefit Advisory Service (DBAS). The DBAS business plan provides the foundation of the AAO Third Party Administrator (AAOTPA) which is under the wing of AAO Services Inc. (AAOSI) for busi-

ness/accounting purposes. Dr. **Norman Nagel** will represent COHC at future AAOSI board meetings.

Dr. Nagel summarized issues discussed with Dr. **Wayne Thompson**, ADA, as a result of meetings with the Health Insurance Association of America (HIAA). Items discussed included code bundling, proposed orthodontic-specific CDT-3 codes, denial based on duplicate procedures previously filed by the patient's general dentist and the practice of direct assignment of benefits.

Council members expressed appreciation to Dr. Nagel for his two years of service as Chair of the Council and to Dr. Poole for his long-term service on COHC.

Council on Orthodontic Practice

COOP met in February 2002 and again at the Annual Session in Philadelphia.

The traditional transition seminar that has been sponsored by COOP at the Annual Session was very well received. **Richard Collier**, **Randy Berning** and **Larry Domer** were outstanding and gave the attendees an excellent understanding of the issues that face both the buyer and the seller when entering a practice transition as well as a synopsis of the necessary requirements for a smooth, successful transfer. Anyone who couldn't attend can order the tapes of the presentations through AAO audiovisual services. Notable at this conference was the reduced attendance from previous years which may be an indication that the topic is reaching a saturation point. COOP will study this trend and make necessary revisions.

The slightly abbreviated transition meeting for the Annual Session in Hawaii will highlight two excellent speakers – Dr. **Jerry Clark** and Mr. **Stan Holt**.

An innovative business seminar for the practicing orthodontists entitled, "Orthodontist as CEO," will be held February 7-9, 2003, in Tampa, Florida. Registration opened in June and I encourage all interested MSO members to register early. During the two and one-half days, the attendees will learn about the responsibilities of the orthodontist as an entrepreneur and business manager. With practices getting larger and staff sizes increasing, the CEO requirements of an orthodontist are taking on new meaning.

COOP has been able to bring some of the best business minds in orthodontics to discuss the role of an orthodontist as CEO – **John McGill**, **Bill O'Neill**, **Char Eash**, **Larry Mickey** and **Charlene White**. **Randal Berning**, who has a background in business and healthcare law, will integrate important concepts presented in each session and will differentiate issues that are pertinent to the young practice, mid-term practice and the senior practice. Each participant will receive a course workbook to aid them in the application of the learned business principles as they return to their practices. This is going to be a great meeting!

As part of COOP's initiatives regarding staff training and retention, a pilot Train-the-Trainer program was held last October. The final program was limited to 30 clinical and 30 administrative staff. We were able to develop an excellent assessment of the value of future Train-the-Trainer programs.

The concept is to have outstanding trainers teach AAO members' staff the latest methods in staff training. The "graduates" of the Train-the-Trainer program could then share these methods and concepts within their office and with other local orthodontic offices and, eventually, at state and constituent meetings. COOP has requested and the BOT has approved of a full-day Train-the-Trainer program at the 2004 Annual Session in Orlando. The current plan is to have Digiscript "capture" the program and present it on the AAO Web site to aid all AAO members.

Several years ago the AAO BOT created a Practice Alternatives Oversight Committee to guide the development of a program that would teach orthodontic residents about the variety of practice options that are available. This program was presented in most of the orthodontic residency programs at the approval of the department chair. Over the years the program was very successful in achieving its mission, and it has been determined that COOP should administer this program and, perhaps, update the binders that are presented to the students.

COOP continues to be involved in refining a concept of a career pathway for orthodontic staff in recruitment, training and retention. All staff will be more likely to have greater longevity in offices if they feel that their position is a career.

Recruitment – COOP members worked with AAO staff to develop a brochure that can be used to recruit staff, including those from the captive audience of patients and parents of patients. Check with the AAO to order this well-designed brochure.

Training – If you are looking for staff training ideas, go to the AAO Web site and download the *Orthodontic Staff Training Syllabus*. This syllabus will help any

office develop a library of effective training materials.

Retention – Today’s staff seem to be very interested in their work environment, benefits and salary. They also desire training so that they can become productive members of the treatment team. This topic will be covered at the “Orthodontist as CEO” conference.

There are several additional items under consideration by COOP. The current *Office Design Manual* was designed six years ago and is dated. A subcommittee was formed to evaluate the possibility of updating the manual and producing the new one in a format that is usable by members via the AAO Web site.

COOP members have made suggestions to COGA regarding the impact that the new patient privacy regulations will have on orthodontic practices. In addition, two members of COOP were assigned to the test construction committee of DANB.

Also under consideration is the development of a patient handout on high risk/decay active patients. It is important to identify high risk caries patients so that we can aid in the prevention of decay during orthodontic treatment.

Council on Scientific Affairs

The Council on Scientific Affairs (COSA) met on January 13, 2002, in St. Louis. Eighteen entries were reviewed for consideration of research awards and, by consensus, the following research projects were selected for 2002 awards:

Milo Hellman Award: COSA elected not to award the Milo Hellman Award for 2002.

2002 Harry Sicher First Research Essay Award:
Dr. **Riyad A. Al-Qawasmi**, Indiana University, for his project, “Linkage and Association of an Interleukin 1B Gene Polymorphism with External Apical Root Resorption Associated with Orthodontic Treatment.”

2002 Thomas M. Graber Award of Special Merit:
Dr. **Renata Rzazewska-Johnson**, University of Michigan, for her project, “A Prospective Gnathologic Assessment of the Effect of Orthodontic Treatment on Mandibular Position.”

2002 Thomas M. Graber Award of Special Merit:
Dr. **Derek A. Straffon**, University of Michigan, for his project, “The American Board of Orthodontics Grading

System: A Validation Against Contemporary Orthodontic Opinion.”

2002 Thomas M. Graber Award of Special Merit:
Dr. **Suzanne Cziraki**, University of Toronto, for her project, “The Reproducibility and Accuracy of Cephalometric Analysis Using Different Digital Imaging Modalities and Image Compression.”

These winners presented abstracts of their research at the AAO Annual Session in Philadelphia in May.

Sixty-eight applications to present oral abstracts at the AAO Annual Session were reviewed and, by consensus, 40 were selected. The remaining submissions were requested to change format to either table clinic or posterboard presentations. We also reviewed and granted 86 requests for table clinics and 136 requests for posterboard presentations.

The Council agreed to request permission to address the Orthodontic Educators Conference preceding the AAO Annual Session in May. COSA reviewed the current status of the California Proposition 65 issue and agreed that no action is appropriate at this time. The Council will continue to monitor this situation.

By consensus, the Council agreed that the AAOF PARC be encouraged to solicit proposals regarding the Legacy Project, as requested by the *AJO/DO*, and initial funding of legitimate new orthodontic programs. The proposed budget for 2002-03 for COSA totals \$14,500.

As a follow-up to the January 13, 2002, meeting, the AAO Board of Trustees agreed with the COSA recommendation to permit the Council chair to address the 2002 Orthodontic Educators Conference to present information on the Research Award submission process. The Board also agreed to encourage the AAOF to consider partial funding of the *AJO/DO* Legacy Project (making past issues available online). The Board also determined that it would not be appropriate to suggest that the AAOF provide funding for new orthodontic program start-up costs.

The next meeting is scheduled for January 12, 2003, in St. Louis.

American Association of Orthodontists Foundation

As of the adjournment of the 2002 AAO Annual Session, the AAO Foundation Endowment Campaign, A CASE FOR THE FUTURE, had realized a total of \$19.2 million in pledges, of which \$12.6 million has been redeemed. This year again looks very promising with just under \$1 million in pledges through the end of the Annual Session. The campaign is well on its way to its fourth consecutive year of more than \$2 million in pledges.

We now have a total of 249 Regents. Thank you to Dr. **Gregg G. Hipple**, Cottage Grove, Minnesota, one of thirteen colleagues who moved up to the Regent level at the Annual Session. While accounting for only about seven percent of all pledges, those individuals pledging at the Regent level or higher account for more than one-third of all dollars pledged. Regents have up to ten years in which to redeem their pledges. If you are thinking of becoming a Regent, consider pledging now.

Nationally, the participation rate among AAO members is 28 percent, while the MSO has a 32 percent participation level. I always have been proud to represent the MSO. Please remember that the participation goal is a pledge from at least one-third of all AAO members.

The AAOF received a total of 62 proposals requesting more than \$1.2 million in support in 2002. After the applications had been reviewed by the Planning and Awards Review Committee (PARC), the AAOF BOD determined to fund ten Orthodontic Faculty Development Fellowship Awards, two Center Awards, five Biomedical Research Awards, one Program Award and a gift (\$1,000 per institution and \$400 for each second-year resident) to every graduate orthodontic residency department in the U.S. and Canada, for a total of \$469,419 for 2002. Once these funds have been disbursed, the AAOF will have given more than \$3.8 million in support of orthodontic education and research since the initiation of the Foundation’s Endowment Campaign.

Dr. **Chin-Yu Lin**, Saint Louis University, received an Orthodontic Faculty Development Fellowship Award and it was designated the 2002 Robert M. Ricketts Sunflower Orthodontic Fellowship Award. Dr. **Thomas Southard**, University of Iowa, received a Corporate Center Award.
