Thanks to the advance work of Dr. **Steve Litton**, MSO representative to AAO's Council on Membership, Ethics and Judicial Concerns, a number of resolutions passed that will streamline the membership application process. Please see the COMEJC report on page 9.

I also thank Dr. **Kevin Horner** for his service to our membership as our representative on AAO's Council on Communications. As the COC is responsible for implementing the new public awareness program funded by the House-approved dues assessment, he will be busy making sure members see a return on their investment.

Education and faculty salary augmentation also were a big portion of House discussions. The House approved allocating two million dollars from AAO reserves to augment faculty salaries and benefits at all accredited postgraduate orthodontic residency programs in the US and Canada. In addition, Dr. **Brent Larson**, who chaired Reference Committee 3, assisted in a recommendation that AAO's existing Task Force on Recruitment and Retention of Faculty should address MSO's two resolutions along with a resolution from SAO on strategic planning for the future of orthodontic education.

Trustee's Report

Thanks and congratulations to the MSO representatives to the 2006 House of Delegates (HOD). This was a watershed year for the HOD, as for the first time in decades, there were major changes in the way in which it does its business. The House meets during the AAO Annual Session and is the policy-making body for the AAO and, thus, the delegates, apportioned on the basis of membership in the eight regional constituencies, are challenged to evaluate the issues before the AAO and develop positions and programs that will serve as the basis for the Association for the next fiscal year—and the future.

The procedures for the House were set up originally at a time when travel was more difficult and the governance of the AAO was really focused on the individual constituencies which held their own meetings and responded directly to the concerns of the members within their regions. As the "world has gotten smaller," organizations have seen a move toward a national focus for their members' professional education as well as agendas and policies, and the AAO has followed this pattern.

Over 20,000 attended the recently held Annual Session in Las Vegas. The breadth of offerings on the scientific program for both doctors and staff was exceptional...and many sessions had standing room only. The part of the meeting most attendees did not see was the "political" side; i.e., the meetings of the individual constituent representatives and the two sessions of the HOD. Traditionally, at least four of the meeting days were spent at various on-site caucuses and meetings to complete the agenda of the Association. Two years ago, the MSO won the support of our colleagues from around the country in shortening the time commitment at the Annual Sessionalmost in half! The new MSO-endorsed plan took effect at the Las Vegas meeting. The upside for those who served in this leadership role was that they, too, were able to attend portions of the scientific program and the technical exhibits and share more time with staff, colleagues and friends.

The big question was, would the MSO-supported changes actually work? The answer was a resounding YES! Elsewhere in this issue of the *MSO Newsletter* you have reports on the accomplishments of the MSO delegates, but suffice it to say that with a positive attitude toward changing a system that had been in place for many years, we were able to work more effectively and efficiently and still accomplish the business of the organization in a manner responsible to the membership. In this age of electronic communication, we now have been able to allow those who serve to do so without severely compromising their own participation in our meetings.

In each of these columns I try to highlight a special membership program that will be helpful to you. While

many of our AAO programs are specific to situations some of us may or may not experience, there is one area where we all share interest and that is the development of our staff. The AAO has been working to find a program that would make it easier to train new hires and upgrade those who have had only very

basic training. That is why the American Association of Orthodontists Services, Inc. (AAOSI), the for-profit subsidiary of the AAO, is working with the Academy of Orthodontic Assisting (AOA), a leader in online, self-paced orthodontic staff training, to make the AOA's curriculum available to AAO member orthodontic staff. This exclusive AAOSI-approved educational program — "Orthodontic Assisting – Technique and Theory" — is a program developed and managed by Dr. **Douglas Depew**, an AAO member. It has an intensive online curriculum that provides standardized formal training and chairside education.

The Web-based staff training program teaches fundamentals of orthodontics and is designed exclusively for self-paced home study. Each student has access to the program for 90 days - and there is an option for an office to purchase the training program for an entire year. Students complete each of the 14 educational modules in sequence and take an online test after each one. Your staff member and you, as the doctor/sponsor, have access to the results of these tests. An online AOA support instructor stays in close contact via e-mail with individually registered students throughout the program. Students and instructors also interact via a message board and chat room. Because there are a lot of photographs in the program, high-speed Internet access is recommended. Upon successful completion of the program, the students receive Academy Certified Orthodontic Assistant (ACOA) status.

In addition to the online program, The Clinical Efficiency Retreat — a hands-on, intensive two-day workshop — builds on the educational foundation provided by the online program. While not required for the ACOA designation, this "hands-on" session compliments the online training using clinical instructors specially trained to help the new staff member.

AAO Council Reports

These reports are submitted by MSO's representative on each of these councils.

Council on Communications

This summer, COC will be working with the AAO's marketing communications partner, Schupp Company, to launch "More Than a Smile," a two-year public awareness campaign that will promote the unique qualifications of AAO-member orthodontists. The campaign, which will include television, magazine and Internet advertisements, will cost \$3.87 million annually and will run in 2006 during the months of October-December. The AAO House of Delegates approved the campaign and the funding proposal in May in Las Vegas.

A two-year \$450 member assessment will fund the majority of the campaign, approximately \$3.45 million annually. Approximately \$420,000 from the Association's financial reserves will pay for the remaining balance of campaign expenses for this fiscal year.

To review the proposed television commercial, log onto the member Web site, <u>www.AAOmembers.org</u>. A link to the public awareness campaign information is posted on the home page. Please note that the commercial posted on the Web site is not the final version; it was created using existing video footage in the public domain. The AAO is in the process of casting for the commercial and will shoot the final footage in the coming months.

At the July 21-22, 2006, meeting, the Council will continue to evaluate and update <u>www.braces.org</u>, the AAO's consumer Web site. The updated site, that recently went live, functions as a valuable consumer-friendly site to which you will want to send your patients.

The Council, in collaboration with COMEJC, revised the AAO Logo Standards Manual to allow greater usage by individual members as well as expanded usage to include student and international members. The idea is to have greater exposure of the logo to help "brand" the AAO.

The Council also will develop a rapid palatalexpansion brochure and a brochure about fiberotomies and

Council on Governmental Affairs

The Council on Governmental Affairs met in

March in Washington, DC. Actions were taken by the Council on a number of issues.

The Council considered several initiatives to pursue with the cooperation of the AAO's component organizations. The Council submitted resolutions to the Board of Trustees concerning state sales taxation of orthodontic supplies and/or services and the portability of specialty licensure. Additionally, the Council is concerned about the proliferation of federal and state-funded dental clinics that engage in the private practice of orthodontics. The AAO's legislative counsel will research the issue and develop an action plan for the Council's consideration during its September 2006 meeting. The Council also recommended that the AAO inquire of other specialty groups during the next Dental Specialty Group meeting as to their willingness to encourage their component organizations to join the AAO's efforts regarding specialty licensure.

The AAO's legislative counsel gave a comprehensive report on the AAO's government relations program, outlining possible areas for improvement. After discussion, the Council decided to invite Mr. Chris Vranas, the AAO's Executive Director, to host a strategic planning session for both the Council and the AAOPAC during its September 2006 meeting. Additionally, future editions of the AAO's *Bulletin* will carry stories relating to how proposed legislation and regulations could negatively affect AAO members. The articles will highlight what the AAO has done to prevent the harmful initiatives.

The COGA Chair appointed a subcommittee of the Council, along with legislative counsel, to periodically review the AAO's Government Relations Web site and provide comments on what content should be added or eliminated. The Council also determined that current legislative updates be placed on the site as well as other useful information such as position papers on legislation and past articles of the *Bulletin* pertinent to the Government Relations Program.

The Council's resolution proposed alternate language regarding the issue of "access to care" in the Strategic Plan stating that the AAO generally opposes the use of federal money for orthodontic treatment.

The Council reviewed the proposed AAO/AAO-PAC dues statement and noted that it will probably lead to less confusion and increased contributions to the AAOPAC.

The Council will hold its next meeting on September 9-12, 2006.

Speaking of our Web site... we made some major changes in the last six months, so if you haven't been there lately, please check it out! We have tried to streamline the interface and improve each section. Also, in January we launched the new AAOEXPRESS home page interface. If you're not already using this as your portal to the Web, please give it a try! You can customize the page to include all of your favorite links and news bulletins; plus, it will update you on the latest AAO news and alert you to new and "hot topics" discussion groups.

The Web site soon will include an online version of the AAO Practice Opportunities and Transitions Job Placement Program and a classified ad program for use by AAO members.

The AAO now offers Web development and Web hosting assistance to constituent and component societies. At this time there are three constituent groups (including MSO) and one component group (Illinois site is under development) using the Web site template provided by the AAO. At least five additional component societies already have expressed interest in using the template. The Council also has been actively involved in improving the AAO Distance Learning Program. If you missed the Annual Session in May, many of the lectures will be found this summer on the Web site in video and audio formats.

Dr. **Will Engilman** (SAO) is helping develop a videoconferencing program using Internet2 which could potentially connect multiple universities and expand our ability to share faculty resources among orthodontic

departments. The University of North Carolina, The Ohio State University and University of Louisville currently are involved in the project. The Internet2 is a research network connecting universities and research institutions via high bandwidth network. Video conferencing has the potential to facilitate and enhance orthodontic resident training by bringing remote presenters to the seminar setting. The potential advantage for the presenter is reduced time and travel considerations with minimal impact on possible private practice demands. The advantage for the orthodontic residency program is greater diversity in content, time recovery for full-time instructors and a potential reduction in residency costs.

The AAO Board of Trustees recently reappointed Dr. **Bill Harrell** as a representative from COIT to the ADA Standards Committee on Dental Informatics. This group developed the standards for digital orthodontic patient records. In addition, the AAO Board of Trustees agreed with a COIT recommendation that the AAO adopt the position that the electronic data standard should provide a way to:

- easily exchange patient data from one system to another
- easily exchange patient data between health care providers
- share patient data between different software systems within the same practice, thus eliminating the need to maintain different sets of data

• ensure and secure patient data

And further, the AAO officially and publicly supports the Digital Imaging and Communication in Medicine (DICOM) standard.

Council on Insurance

COI recently convened to review and analyze the performance of AAO-endorsed insurance plans and to proceed with related matters in the advancement of AAO insurance plans. Over the preceding six months, the descriptive parameters used to measure the performance of AAO member benefit insurance plans indicate solid financial strength and high member value. Participation in Life, Disability, Professional Liability, and Business Office Package insurance plans continues to increase.

Persistence, as measured by policy renewals and the number of participants in multiple plans, remains one of the -continued on next page

highest nationally among group plans. Financial reserves, which provide stability to plan costs and security against future claims, continue to grow. Claims experience in the life and disability plans has been very favorable. Claims experience in the AAO-endorsed medical insurance plan continues to be problematic, but still substantially below the national trend which currently projects that medical costs will continue to rise at approximately 17% annually. The business office package protection offered through an AAO-endorsed plan continues to function as intended, reporting substantially higher claims paid in response to last year's disastrous hurricane season.

COI continues to recommend serious consideration of employment practices liability insurance to protect employer-orthodontists from employment-related claims which very easily eclipse the financial exposure orthodontists encounter in professional liability claims. The Medical Benefits Desk, staffed by JLT Services, now AON Affinity Services, remains available to meet the insurance needs of members in states where conventional AAO-endorsed plans are not available and for meeting the insurance benefit requirements of orthodontic office staff.

Pertinent actions by COI included recommendation of a premium increase, well below the national trend, for participants in the medical insurance plan; formation of a committee to explore reinstating a premium credit to participants in those insurance plans contributing to the increase in reserves; and continuation of the production of a DVD, in partnership with the AAO Insurance Company, to be distributed as a member benefit to members in practice 10 years or less, explaining the insurance needs of the orthodontist and the available insurance plans to satisfy those requirements and providing sound risk management principles in the area of professional liability.

Council on Membership, Ethics and Judicial Concerns

The 2006 House of Delegates in Las Vegas was definitely a House concerned with membership issues. Aside from the two major issues of the public awareness campaign and the funding of education, over a dozen different resolutions relating to membership issues were discussed and voted upon.

The associate category of membership has been eliminated. This category was for those finished with their

education, so no longer student members, but not yet active in a constituent. Now, upon graduation, student members automatically will become Active members of the organization and can vote as well as hold office, and the dues/ assessment structure still will be a graduated process for these new active members.

The AAO and each constituent had numerous membership application forms based upon the category of membership as well as the constituent. Those have been reduced to a single application. In addition, applications for the various categories of membership were sent to the AAO or the constituent, depending upon the category of membership requested. Now, all categories of membership are sent to and processed by the AAO in St. Louis. Once processed, they are sent on to the appropriate constituent. Moreover, constituent application fees were standardized, are the same amount for all constituents and now are collected by AAO.

Currently, ADA membership is mandatory to join and belong to the AAO. This topic, brought before the House previously, again was discussed with many good points, both pro and con. This was the only membership resolution that was defeated; therefore, mandatory ADA membership is still a requirement for AAO membership.

Several other resolutions were passed which included:

- COMEJC will handle not only ethical cases but also membership disputes, and the bylaws were rewritten to include this provision;
- Student members become members upon acceptance into an orthodontic program. They do not have to wait until they actually start their formal orthodontic educational program.
- The bylaws also were changed to allow life membership after age 65 and 30 cumulative years of membership, not 30 consecutive years of membership.
- To become a retired member, one must have belonged for at least 10 cumulative years, not necessarily 10 consecutive years.

In addition, the use of the AAO logo was expanded upon for most categories of membership. This will help in "branding" the AAO member as the orthodontist to see for orthodontic care.

Having resolved these issues should help our organization be more efficient and user-friendly to our members and potential members.

Council on Orthodontic Health Care

The Council on Orthodontic Health Care met in St. Louis in January. Our meeting focused on two primary issues: access to orthodontic health care and the insurance industry's involvement with the specialty.

The AAO Board of Trustees requested that the COHC work with COGA to undertake a study to make recommendations for increasing access to quality orthodontic care in states with underserved or impoverished areas with a final report due to the 2006 House of Delegates. The problem is becoming localized among populations with limited access to care and primarily situated within the realm of primary care dentistry. The problem is further compounded by an extreme shortage of dental providers in severely impoverished areas. The ADA has established several very successful access-to-care programs. The Council has recommended to the AAO Board of Trustees that the AAO approach the ADA proposing a possible partnership between the associations, with COHC working in concert and with combined resources to address the issue on programs such as "Give Kids a Smile." In addition, the Council recommends that the AAO perform a demographic study to identify the locations of current practicing orthodontists and identify areas of population density to pinpoint areas of orthodontic need.

Since the 2005 AAO endorsement of the Virginia Brown Community Orthodontic Partnership, also known as the Smiles Change Lives (SCL) Program, the program has continued to grow and expand. Currently, new programs are being launched in the St. Louis, Missouri, and Minneapolis/ St. Paul, Minnesota, areas this year with at least three new areas being targeted for expansion next year. At the recommendation of the AAO BOT, COHC member Dr. Robert "Bob" MacLean of Chatsworth, California, has agreed to serve on the SCL National Advisory Board and will represent AAO interests as the program evolves. A publicity campaign is underway including posting information on AAO member and public Web sites, press releases to educate the public and recruit new orthodontists into the program and feature articles in the Bulletin and Straight Off the Wire. On the Council's recommendation, the AAO made a donation to the SCL program of \$20,000. For more information on the SCL program, consult the AAO Web site or www.smileschangelives.org.

The Council continues to study CDT coding issues. COHC members Drs. **John Harrison** and **Gary Wiser** represented the AAO at the February ADA Code Review Committee meeting in Chicago. On behalf of the AAO, COHC representatives submitted the following codes:

- •Surgical placement of temporary anchorage device (TAD) for orthodontic treatment: microimplant without surgical flap.
- •Surgical placement of temporary anchorage device (TAD) —continued on next page

for orthodontic treatment: microimplant with surgical flap.

- •Surgical placement of temporary anchorage device (TAD) for orthodontic treatment: screw retained plate requiring surgical flap.
- •Repair of removable retainers and rebonding/recementing of fixed retainers.
- •Revision to existing retention code: "also used for repair of broken retainers and rebonding/recementation of loosened fixed retainer."
- •Comprehensive orthodontic evaluation: new or established patient.
- •Post-orthodontic treatment retention visit.

An ongoing problem is the insurance industry's practice of capping their clients' lifetime orthodontic insurance benefit. Ancillary procedures such as extractions, exposure/ligation of impacted teeth and adjunctive periodontal procedures have been known to be charged against the orthodontic benefit. The Dental Benefit Advisory Service Hotline is the AAO staff liaison to the COHC and continues to provide information and help to member offices on problems related to third-party insurance payers, coding recommendations, strategies and practice management issues.

If you or your staff have specific insurance questions on behalf of your patients, please call the AAO Hotline. If, however, you have a general concern regarding how insurance falls short in its service to your patients, please contact me and I will voice your concerns to the Council.

Special recognition is due Drs. James Wheeler, Iowa City, Iowa; James Mutti, Gladstone, Missouri; Terry Guenthner, Rochester, Minnesota; Gilbert Schmidtke, Appleton, Wisconsin; Carlin Wiemers, Mankato, Minnesota; Patrick Foley, Lake Zurich, Illinois; Robyn Silberstein, Highland Park, Illinois; and Brian Jesperson, Bismarck, North Dakota. These individuals voluntarily and successfully completed the recertification process in 2006. To date, 203 ABO Diplomates have recertified. We hope that more Diplomates will complete this process.

The Board gave almost one hundred examinations with 46 regular case displays presented and with 38 candidates completing their certification process this past February. In addition, the Board examined 50 Pilot Study presentations by orthodontists who completed their residencies in 2005 or 2006. Seventeen training programs, including the University of Illinois – Chicago and Mayo Graduate School, agreed to participate in a study to see if residents could complete cases in their training programs to fulfill ABO requirements.

Objective Grading System Pilot Study scores averaged slightly less than two points higher than the OGS candidate scores from private practice. We saw more extraction cases than we expected as well as quite a few successfully treated full-step Class II cases. The Board was very impressed with the knowledge, demeanor and poise exhibited by these candidates in their oral interviews.

With input from this Pilot Study, the requirements for the Initial Certification Examination will be the same as the requirements for the First Recertification Examination.

Students graduating from programs in 2006, who passed the written examination, will be invited to present cases in February 2007 if they have cases from their residency that meet the requirements. If not, they have up to three years to present the cases. The cases presented must have appliances placed and removed by the recent graduate. A ten-year time-limited certificate will be issued at successful completion of the Initial Certification Examination. The clinicians will need to continue to complete recertification examinations every ten years to stay certified throughout their careers.

The Board's first examination given entirely on computer was taken by 439 candidates and was a success. Pearson Vue testing centers have an excellent security protocol, and the system is encrypted and has rigid internal controls to prevent dishonesty. The residents were happy as they could take the exam in their residence city on any day of a given week in April.

Due to the increased interest in taking the written examination, the Board is going to offer a one-time special written examination the first week of December at Pearson Vue Centers. Anyone interested in this examination should contact the ABO office.

The Gateway Offer will expire June 30, 2007. The Board will accept Gateway applications from students completing their residencies anytime in 2007, dependent on their passing the written examination in 2007. Over 800 orthodontists have accepted the Gateway offer which has increased the percentage of Diplomates to 35%.

Dr. Herb Klontz, Oklahoma City, Oklahoma, received the Albert H. Ketcham Memorial Award for 2006. The ABO presented George Selfridge with the 2006 Earl E. and Wilma S. Shepard Award, and Drs. Richard Aubrey (posthumous), James Baldwin and Edward Genecov were presented with the Dale B. Wade Award of Excellence in Orthodontics.

The announced winners for 2007 in Seattle are Dr. **Bjorn Zacherson**, Oslo, Norway, as the recipient of the Albert H. Ketcham Memorial Award and Dr. **Bonham Magness**, Houston, Texas, as the recipient of the Dale B. Wade Award of Excellence in Orthodontics.

An ad hoc committee of the Missouri Dental Association (MDA) was appointed and met May 12 to discuss the Expanded Functions Dental Assistant (EFDA) rules for orthodontic assistants. After much discussion, the committee decided to ask the Trustees of the MDA to recommend to the Missouri Dental Board that they rescind the expanded functions that have been granted to EFDAqualified orthodontic assistants. This would mean that orthodontists would delegate tasks to "qualified orthodontic assistants" under their direction, that the assistants would not need to be EFDA-certified, and that the orthodontists would be responsible for all reversible tasks that they delegate to an assistant. Part of the reason for this recommendation is that the orthodontist ultimately is held responsible anyway.

If the Trustees approve this change, they will send this recommendation to the Missouri Dental Board, which will recommend a change to the Missouri Dental Practice Act. The process could take up to two years to be approved; so in the interim, make sure to have your staff members certified and have them take the expanded functions exam to comply with the current state laws.

Our Missouri meeting for 2007 will be held in Kansas City in conjunction with the Kansas Society of Orthodontists.

Members who are interested in becoming part of a practice coverage agreement should contact Dr. **Mark Dake**. Agreements already exist that cover parts of the urban areas of Missouri but do not exist to cover the rural areas of the state.

at the Fellow level of \$50,000. Also, there are 183 individuals who have made a commitment to the Keystone Society and have included the Foundation in their estate plans.

The focus for this funding round of the Awards Program will continue to support "junior faculty" (i.e., Orthodontic Faculty Development Fellowship Awards, Postdoctoral Fellowship Awards and Biomedical Research Awards) and collaborative projects (Center Awards).

The Board has determined that there will be no funding available in 2007 for any of the other announced categories, which include Program Awards, Educational Innovation Awards, Research Aid Awards or Gifts in Support of Orthodontic Education.

Awards Materials are expected to be available online either through the AAO Web site (<u>www.AAOmembers.org</u>) or the AAOF Web site (<u>www.aaofoundation.net</u>) by July 1. Since 1994, the AAOF has designated approximately \$5.8 million in awards to benefit orthodontic education and research with 92 Orthodontic Faculty Development Awards and 137 Research Awards being given.

Awarded for the first time at the 2006 Annual Session in Las Vegas was the Eugene and Pauline Blair American Association of Orthodontists Foundation Distinguished Service Award to Dr. **Eugene** and **Pauline Blair** making them the first recipients of the award named in their honor. The AAOF Board of Directors established this highly prestigious award at its spring meeting to recognize those who have "made exceptional contributions to the furtherance of the mission and goals of the Foundation."
