## Frank Green receives Shepard Award

The Midwestern Society of Orthodontists' Board unanimously selected Dr. **Francis (Frank) P. Green** who practiced in Bloomington, Illinois, as the recipient of the 2011 Earl E. Shepard Distinguished Service Award. The award was presented in Chicago in May at the MSO Business Meeting held in conjunction with the AAO 111<sup>th</sup> Annual Session.

Frank received his dental degree from Loyola University in 1964. Upon graduation, he joined the U.S. Navy and was stationed with the United States Marines in San Diego, California.

After completing his military career, Frank practiced general dentistry in Elmhurst, Illinois, for approximately ten years. In 1976, he returned to graduate school and obtained his orthodontic specialty degree from Northwestern University. While there, he had the privilege of studying under the tutelage of individuals such as Drs. **Hal Perry, Don Apfel, Bailey Jacobson, Jim Jensen, Ray Warpha** and many other fine educators. Upon graduation, Frank joined the orthodontic practice of his mentor and friend, Dr. **Hal Perry**, the chairman of the Department of Orthodontics at Northwestern University.

After associating with Hal for two years, Frank moved to Bloomington, Illinois, and joined the practice of a good friend and former schoolmate, Dr. **James Smith**. Dr.

Green, along with partners Dr. Smith and Dr. **Fred Lauder**, enjoyed their partnership for many years. With the help and support of his partners and family, he was able to serve on many and various boards, commissions and committees at the local, state and national levels. He enjoyed interacting with the leaders of the orthodontic and general dental communities, including Drs. **Tom and Lee Graber, Steve Marshall, Spencer Pope, Tony Maloni, Steve Roehm, Ara Goshgarian, Frank Whipps, Mike Hayward, Dave Cleven, Jim Kohl, Joe Crisham, Nick Gordon** and many others.

Just a few examples of Frank's wide variety of involvement include being president of the McLean County Dental Society after serving on every committee; trustee of both the Illinois State Dental Society and the Illinois Society of Orthodontists; and liaison to the ISDS from the ISO. He served the ADA as a delegate and alternate delegate for a

The AAO Professional Advocacy Conference is scheduled this year for January 23-25 in Washington, D.C. The political landscape should be particularly interesting this year as we head into a presidential election. As always, this conference is designed to have the collective voice of orthodontics heard on Capitol Hill, and the AAO is continually looking for members willing to spend time advocating for our specialty. Another exciting event happening January 27-29 is the 2012 Mid-Winter Conference in Marco Island, Florida. This event is co-sponsored by the American Academy of Pediatric Dentistry. The conference is designed to be of value to both orthodontists and pediatric dentists and I suggest you invite a local pediatric colleague to attend with you. A wide variety of topics will be covered including crowding and space management, missing teeth, treatment of the developing crossbite, protection of teeth during orthodontic treatment, adolescent patient motivation and learning issues, and new technologies. The planning for the AAO Credit Union continues. The AAO board accepted nominations for the AAO Credit Union Board of Directors and other appointed positions. This action is consistent with the AAO's critical issue dealing with general dental and healthcare relationships.

Finally, the AAO board received the initial results of the recent membership needs assessment survey. This survey is conducted every five years and the data help shape decisions and directions for the organization. Of note for the MSO, this was the first time that questions about satisfaction with the constituent organizations were included and the MSO was rated the highest of all of the constituents with an excellent/very good rating of 67%. This is just one indication of the great job that the MSO officers and staff do for all of us. Special thanks to Executive Director **Kristi Burmeister** and her team for their level of support! # AAO Council and Affiliate Group Reports

These reports are submitted by MSO's representative on each of these councils and affiliate organizations.

## Council on Communications

The Council met in July and December in St. Louis and via conference call in November.

The Council would like to make arrangements to have an orthodontist speak at local and regional meetings sponsored by the following healthcare professionals:

- Dental hygienists
- School nurses
- Pediatric nurse practitioners
- Pediatricians
- Speech pathologists
- Psychologists
- High school counselors
- Physicians' assistants

A calendar of local and regional meetings currently is being generated and will need to include key contacts at AAO component and constituent levels. For example, if the COC were to learn about a meeting in Jefferson City for Missouri hygienists, the president/officers of the Missouri component society would be made aware with a "cc" to **Kristi Burmeister** (MSO executive director) so that the component could contact the group and offer a speaker.

Drs. **Hugh Phillis** and **Devek Frech** are working in union with AAOMS on a DVD about oral and maxillofacial surgical procedures for orthodontic patients. The filming occurred in August in Chicago and featured Drs. **Lee** and **Katie Graber** as the AAO spokespeople and Dr. **Anthony Spina** as the AAOMS spokesperson. They will be able to review the footage before the close of 2011.

Dr. **James Paschal** will be delivering a presentation during the 2012 Annual Session that will showcase the different ways members may customize Consumer Awareness Program materials.

*Ask an Orthodontist* will be featured on the home page of [yourlifeyourmile.org](http://yourlifeyourmile.org) and will provide consumers with an opportunity to ask AAO-member orthodontists questions about orthodontic treatment. In addition to relying on consumers to post questions, staff has asked Ruder Finn to search orthodontic blogs and other social media outlets for questions being asked by consumers. There will be six Council members ready to respond to consumer inquiries and staff is aiming for a turnaround time of two business days. AAO legal counsel will be asked to review the responses prior to posting.

In addition to text answers, staff also would like to provide audio clips, video clips, and possibly some illustra-

tions as responses to member inquiries.

The Council discussed the Millward Brown Tracking Study and the fact that while the study provides some very useful data, there remain several unanswered questions. Following are a few of the questions for which the Council would like answers:

- Are there fewer kids in braces and trays compared to a year ago because of the economy or are there other factors at work?
- Are there fewer adults in braces and trays compared to a year ago because of the economy or are there other factors at work?
- Why is the number of orthodontists providing trays down compared to a year ago?
- What are parents paying for before getting their children orthodontic treatment?

- Why, according to Millward Brown, are orthodontists now being considered more for trays?

Staff will discuss adding the questions to the tracking study. After a cost estimate is secured, staff will report back to the Council.

## Council on Governmental Affairs

The Council and the AAO will host the 2012 Professional Advocacy Conference in Washington, D.C. on January 23-25. The meeting seeks to build upon the 87 AAO members who attended last year's meeting. Attendees will meet with legislators and staff as well as learn about the AAO's federal advocacy efforts. **Tucker Carlson**, noted commentator and editor of [dailycaller.com](http://dailycaller.com), will be the keynote speaker and will attend a post-address book-signing reception for \$500+ AAOPAC contributors. Additionally, members of Congress, representatives of the ADA and other allied organizations and **Charlie Cook**, pollster and editor of the *National Journal*, will address the Conference. The Council is actively monitoring numerous issues at both the federal and state level, including health care reform and various small business-related tax issues. It also seeks to provide relevant testimony to Congress when the opportunity arises in an effort to represent the interests of orthodontists. Of particular note is AAO's activity on the "1099" issue. The AAO was active in several coalitions which sought repeal of the provision in the health care overhaul bill that would require businesses to issue 1099s to all vendors from which they purchase \$600 or more in goods or services. It also provided written testimony to Congress detailing the cost of compliance. The mandate was, in fact, repealed, largely due to the input from small businesses that would have experienced significant burden from the requirement.

Another topic at the forefront of the AAO's agenda is the repeal of the tax on medical devices, which also was part of the health care overhaul. While the tax, as currently defined, does not apply to orthodontic appliances, it does present a potential future threat to apply to a broader array of devices. Additionally, the AAO is working with the Organized Dental Coalition and others to seek to raise or eliminate the cap on Flexible Spending Accounts (FSAs), currently set at \$2,500 beginning in 2013. Many patients use FSAs to pay for orthodontic treatment, and the AAO believes that the cap will effectively increase the cost of treatment for patients.

The Council is working with the AAO to increase usage of the Legislative Action Center, the online advocacy tool of the AAO. The Center allows AAO members to easily access AAO's positions on issues and send messages to their members of Congress. Last year, the AAO directed members to the site in regard to legislation related to the "1099" issue. Earlier this year, the AAO made available a state program for use by component and constituent groups. This program allows the groups to post advocacy messages targeting state lawmakers and executive departments.

The AAO is chairing the Organized Dental Coalition in 2011. The Coalition is comprised of all organized dental organizations and has worked to increase the efficiency with which organized dentistry communicates efforts to lobby Congress and regulatory agencies.

The Council continues to enhance the AAO's Government Relations Program through its efforts to increase the number of Key Contacts, increase visibility of its lobbying efforts at AAO meetings and focusing on increasing its effectiveness in shaping the policy agenda of Congress.

## Council on Membership, Ethics and Judicial Concerns

The Council met in St. Louis in December to discuss a variety of topics. Of particular value was information shared by Mr. **Jerry Jacobs**, a leading authority on nonprofit organization law, in a discussion of the Association's *Principles of Ethics* and *Code of Professional Conduct* and its associated procedural activities. As a result, a number of the Council's responsibilities will be reviewed and updated.

Group buying promotional entities have recently entered the healthcare delivery marketplace. In addition to encouraging the membership to review the October 11, 2011 *AAO Bulletin* article titled, *Caution on Charity Auctions and Group Discounts*, the Council agreed to issue the following statement regarding the legality of group buying programs:

The participation in group buying programs by healthcare providers has not been conclusively determined to be either legally protected advertising or fee splitting/rebating, which may be in violation of state, provincial or territorial dental practice acts. As such, members should consult with their own legal counsel regarding any potential violation of state laws prior to entering into any arrangement with such entities.

The Council also worked on tasks assigned to it by the Board of Trustees following last spring's Annual Session as well as reviewed requirements necessary for membership categories.

In September 2011, drafts of the 2013 AAO award applications were reviewed by the Council on Scientific Affairs. On October 17, 2011, the Council met via conference call to further discuss the draft applications. In attendance were: Drs. **Frans Currier**, Chair; **Nan Hatch**; **Greg Huang**; **Shannon Owens**; **Bhavna Shroff**; **Lokesh Suri**; **Vincent Kokich**, Trustee Liaison; and Ms. **Jackie Hittner**, Staff Liaison. Discussion items included evaluation of newly drafted criteria for the 2013 Milo Hellman and Harry Sicher Research Awards and Thomas M. Graber Awards of Special Merit. The 2012 applications for the Hellman, Sicher and Graber Awards were reviewed as well.

The following were agreed to by the Council:

- There should be two draft applications, one for the Milo Hellman Research Awards and one for the Harry Sicher Research Awards.
- Applicants who apply for the Milo Hellman

Research Award will not be considered for the Harry Sicher Research Award but would be considered for the Thomas M. Graber Awards of Special Merit.

- Applicants who apply for the Harry Sicher Research Award will not be considered for the Milo Hellman Research Award but would be considered for the Thomas M. Graber Awards of Special Merit.

- The Harry Sicher Research Award eligibility will be for research efforts performed during graduate orthodontic education at the certificate, masters or PhD levels.

- All mention of first research should be removed from the Harry Sicher Research Award.

- The Council will recommend to the BOT that the AAO Award amounts be:

- Milo Hellman Research Award – \$4,000 – up from \$3,000

- Harry Sicher Research Award – \$4,000 – up from \$3,000

- Thomas M. Graber Awards of Special Merit – \$2,500 – up from \$2,000

- Reimbursed travel expenses for all the awards – \$1,000 – up from \$750

It was decided during the conference call to revise the draft applications and e-mail to COSA for approval, then write a recommendation to the BOT regarding the increase in award and travel amounts.

With respect to COSA's strategic plan, Council will continue to encourage AAO members to provide the highest level of orthodontic care and support accredited orthodontic graduate education programs to maintain the highest level of specialty education possible.

the Board on the 2012 elections and discussed various funding strategies to consider this cycle. The upcoming 2012 election will be an extremely important race and very likely will determine what type of healthcare policy our nation will have in the future.

AAOPAC has an ambitious fundraising goal of \$1,000,000 over the two-year political cycle. Currently, AAOPAC averages approximately \$600,000 per cycle. The PAC is growing but only enjoys the participation of 14% of our membership. By contrast, other specialty associations approach 30%. Our goal is very attainable at the 30% level of participation.

Without AAOPAC we would be spending thousands of dollars more per year in our practices by:

- filing multiple 1099 forms for goods and services purchased for over \$600 or more.
- complying with the “Red Flag” rule.
- being subject to regulation by the Consumer Financial Protection Bureau.
- explaining to patients their loss of Flexible Spending Account (FSA) benefits.
- paying excise taxes on medical devices.

AAOPAC is working to protect your profession, but we cannot be successful without your financial support. It is challenging to solicit contributions in the present economy but it is more critical than ever in order to not lose ground on our previously successful advocacy efforts.

The ABO completed the third Clinical Examination in the new St. Louis examination facility November 16-20. There were 27 total team members who participated in administering the Clinical Examination, four of whom were new examiner trainees. The MSO was well represented by Drs. **Vance Dykhouse**, Missouri; **John Kanyusik**, Minnesota; **David Schrody**, Iowa; and **Paul Castelein**, Illinois. The ABO staff is always a wonderful and necessary support group who are indispensable in guiding the daily activities and accomplishing behind-the-scenes work.

The first order of business during the Clinical Examination is to calibrate the examiners using two cases previously graded to a gold standard. The examiners' scores are compared to the standard and any score that is outside the norm by more than two standard deviations is discussed with the examiner. This process is to insure that each examinee receives the same result regardless of which room or examination team they are assigned.

There were 116 examinees who participated. The Initial Certification Examination (new resident graduates) had 29 examinees and ten banked five or fewer cases for future use. These examinees have ten years in which to complete the case requirements for Board Certification. The Gateway process produced 65 examinees and 49 became new Diplomates. The encouraging number was that seven examinees were Beginning Certification (orthodontists that did not take the Gateway offer or are not eligible for ICE). The Board would like to encourage eligible orthodontists to enter into the process through this route so we could examine ten or more per examination. There also were four voluntary recertification examinees. At this examination we started accepting all electronic case submissions on a limited basis. Two of the exam rooms were designated as electronic and two teams of two directors were the examiners. The patient records were all electronic except that the final models must be plaster models which are not produced from electronic models. During the June 2012 examination we will be increasing the number of electronic submissions.

The next Clinical Examination will be February 17-22 in Dallas. It will be the final examination there since it was contracted in order to accommodate the Gateway applicants. The examination is full, however, I would encourage orthodontists who have their cases ready to call the ABO office to fill a cancellation that may occur.

The next Written Examination is scheduled for April 17-20, 2012 at Pearson Vue Testing Centers and
